Part 1—Preliminary

1—Short title

These regulations may be cited as the *Building Work Contractors (Fees) Variation Regulations 2009*.

2—Commencement

These regulations will come into operation on 1 July 2009.

If the period between the grant of the licence and the next date for payment of a fee under section 11 of the Act is less than or more than 12 months, a pro rata adjustment is to be made to the amount of the additional fee by applying the proportion that the length of that period bears to 12 months.

If the period between a date for payment of a fee under section 11 of the Act and the next date for payment of the fee under that section (as nominated by the Commissioner) is less than or more than 12 months, a pro rata adjustment is to be made to the amount of the fee by applying the proportion that the length of that period bears to 12 months.

8	Periodic fee for registration (section 18(2)(a) of the Act) If the period between a date for payment of a fee under section 18 of the Act and the next date for payment of the fee under that section (as nominated by the Commissioner) is less than or more than 12 months, a pro rata adjustment is to be made to the amount of the fee by applying the proportion that the length of that period bears to 12 months.	\$156.00
9	Application fee to vary or revoke a condition of registration (section 13(2)(b) of the Act)	\$126.00
10	Application fee for approval as a building work supervisor in relation to a building work contractor's business (section 19(3)(b) of the Act)	\$97.00
11	Application fee for exemption (section 45(1) of the Act)	\$82.50
12	Fee for replacement of licence or certificate of registration	\$21.60
