Legislative history

1—Short title

These regulations may be cited as the *Fees Regulation (Proclaimed Managers and Justices) Regulations 2002*.

4—Fee for appointment of proclaimed managers

The application fee for a manager to be appointed as a proclaimed manager under Part 5 of the *Oaths Act 1936* is \$22.40.

5—Fee for appointment of certain justices

The application fee for a person to be appointed as a Justice under the *Justices of the Peace Act 1991* for the duration of the person's employment—

- (a) by a particular employer; or
- (b) in a particular position,

is \$34.25.
