## Legislative history

---

### **1—Short title**

These regulations may be cited as the *Fees Regulation (Public Trustee Administration Fees) Regulations 2015*.

### **3—Fee under *Administration and Probate Act 1919***

- (1) The fee payable by an administrator to the Public Trustee for examination of a statement and account lodged with the Public Trustee under section 56 of the *Administration and Probate Act 1919* is \$235 per hour or part of hour.
- (2) The fee payable under subregulation (1) may be paid by the administrator from the estate in relation to which the statement and account have been prepared.

### **4—Fee under *Guardianship and Administration Act 1993***

- (1) The fee payable by an administrator of a protected person's estate to the Public Trustee for examination of a statement of the accounts of an estate and preparation of a report for the South Australian Civil and Administrative Tribunal by the Public Trustee under section 44 of the *Guardianship and Administration Act 1993* is \$235 per hour or part of hour.
- (2) The fee payable under subregulation (1) may be paid by the administrator from the protected person's estate.
