Legislative history

1—Short title

These regulations may be cited as the *Firearms (Fees) Regulations 2019*.

2—Commencement

These regulations come into operation on 1 July 2019.

3—Interpretation

- (1) In these regulations, unless the contrary intention appears—
Act means the *Firearms Act 2015*.
- (2) For the purposes of these regulations, unless the contrary intention appears, words and expressions used in these regulations have the same respective meanings as in the Act or the *Firearms Regulations 2017*.

4—Fees

- (1) The fees payable under the Act and the *Firearms Regulations 2017* are set out in Schedule 1.
- (2) The Registrar may refund, reduce or waive (in a particular case or class of cases) fees that would otherwise be payable under the Act or the *Firearms Regulations 2017*.

Schedule 1—Fees

- 1 Application for grant or renewal of firearms licence (other than a category 11 (dealer) licence)—
 - (a) if term of licence does not exceed 1 year \$99
 - (b) if term of licence exceeds 1 year but does not exceed 3 years \$257

<p>Subject to the fees otherwise specified in items 2 and 3 of this table, one application fee for the grant or renewal of a licence may be payable in respect of an application that involves more than one category of licence (other than an application for a licence authorising the purpose of collecting, or collecting and displaying, firearms—see section 12(4) of the Act). However, a separate application will be required (and separate fee payable) in respect of each category of licence where the term for which the licence is to be issued is not the same (as determined in accordance with section 17 of the Act).</p>
