Citation

1. These regulations may be cited as the Goods Securities Regulations, 1987.

Prescribed goods (s. 3)

2. For the purposes of the Act—

"prescribed goods" includes a motor vehicle or trailer registered by the Registration Authority for South Australia under the *Interstate Road Transport Act 1985* of the Commonwealth (as amended from time to time).

Fees (s. 10)

3. The following fees must accompany applications under the Act:

<i>Application</i>	<i>Fee</i>
(a) Section 5—for registration of each security interest—	
(i) where application is made by magnetic tape facilities	\$6.00
(ii) in any other case	\$7.00
(b) Section 9—for a certificate of registered security interests, if any, in respect of specified prescribed goods	\$5.00
(c) Section 12(3)—for postponement of a security interest to a security interest subsequently registered	\$7.00
(d) Section 14(1)—for compensation	\$28.00

Fees during transitional period (s. 10)

4. (1) During the transitional period (see schedule 2 to the Act) the following fees must accompany an application for registration of a security interest under section 5 of the Act:

(a) where application is made by magnetic tape facilities	\$2.00
(b) in any other case	\$3.00.

(2) This regulation expires on the expiry of the transitional period.
