**Citation**

1. These regulations may be cited as the *Strata Titles (Fees) Regulations 1988*.

**Commencement**

2. These regulations will come into operation on 1 September, 1988.

**Interpretation**

3. In these regulations—

"**the Act**" means the *Strata Titles Act 1988*.

**Fees**

4. The fees set out in the schedule are payable to the Registrar-General in respect of the matters referred to in the schedule.

(a) of the appointment of an administrator of a strata corporation .....	\$ 82
(b) of the removal or replacement of an administrator of a strata corporation .....	\$ 82
