Legislative history

1—Short title

These regulations may be cited as the *Strata Titles (Fees) Regulations 2001*.

2—Commencement

These regulations will come into operation on 1 September 2001.

3—Revocation

The *Strata Titles (Fees) Regulations 1988* (see *Gazette 21.7.1988 p468*), are revoked.

4—Interpretation

In these regulations, unless the contrary intention appears—
the Act means the *Strata Titles Act 1988*.

5—Fees

The fees set out in the Schedule are payable to the Registrar-General in respect of the matters referred to in the Schedule.

- 1 For lodgement of an application for—
 - (a) the deposit of a strata plan \$94
 - (b) amendment of a strata plan \$94
 - (c) amalgamation of two or more strata plans \$94
- 2 For the examination of—
 - (a) a strata plan \$306
 - (b) an amendment to a strata plan \$306

3 For the deposit of a strata plan	\$94
4 For the issue of a certificate of title—

(c) for each unit comprised in an amalgamated plan	\$55.50
5 For the amendment of a schedule of unit entitlements	\$94
6 For the cancellation of a strata plan (including fees for entering necessary memorials in the Register Book)	\$275 plus \$55.50 for each certificate of title issued
7 On lodging a certified copy of a special resolution of a strata corporation amending the articles of the corporation	\$94
8 On lodging any other document with the Registrar-General under the Act	\$94
9 On giving written notice—	
(a) of the appointment of an administrator of a strata corporation	\$94
(b) of the removal or replacement of an administrator of a strata corporation	\$94
