Chiropractic and Osteopathy Practice Bill 2005

A BILL FOR

An Act to protect the health and safety of the public by providing for the registration of chiropractors, osteopaths, chiropractic students and osteopathy students; to regulate the provision of chiropractic and osteopathy for the purpose of maintaining high standards of competence and conduct by those who provide it; to repeal the *Chiropractors Act 1991*; and for other purposes.

The Parliament of South Australia enacts as follows:

Part 1—Preliminary

1—Short title

This Act may be cited as the Chiropractic and Osteopathy Practice Act 2005.

2—Commencement

This Act will come into operation on a day to be fixed by proclamation.

(b) any other therapy declared by the regulations to be restricted therapy;

unprofessional conduct includes-

- (a) improper or unethical conduct in relation to professional practice; and
- (b) incompetence or negligence in relation to the provision of chiropractic or osteopathy; and
- (c) a contravention of or failure to comply with—
 - (i) a provision of this Act; or
 - (ii) a code of conduct or professional standard prepared or endorsed by the Board under this Act; and
- (d) conduct that constitutes an offence punishable by imprisonment for 1 year or more under some other Act or law.
- (2) A reference in this Act to unprofessional conduct extends to—
 - (a) unprofessional conduct committed before the commencement of this Act; and
 - (b) unprofessional conduct committed within or outside South Australia or the Commonwealth.
- (3) A reference in this Act to *engaging in conduct* includes a reference to failing or refusing to engage in conduct.
- (4) Without limiting the generality of the expression, a person who is not a chiropractor or osteopath will, unless exempted by the regulations, be taken to *provide chiropractic or osteopathy through the instrumentality of a chiropractor or osteopath* if the person, in the course of carrying on a business, provides services to the chiropractor or osteopath for which the person is entitled to receive a share in the profits or income of the chiropractor's or osteopath's practice of chiropractic or osteopathy.
- (5) For the purposes of this Act—
 - (a) a *corporate chiropractic or osteopathy services provider* is a chiropractic or osteopathy services provider that is a body corporate and a person occupies a *position of authority* in such a provider if the person—
 - (i) is a director of the body corporate; or
 - (ii) exercises, or is in a position to exercise, control or substantial influence over the body corporate in the conduct of its affairs; or
 - (iii) manages, or is to manage, the business of the body corporate that consists of the provision of chiropractic or osteopathy; or
 - (iv) where the body corporate is a proprietary company—is a shareholder in the body corporate; and
 - (b) a *trustee chiropractic or osteopathy services provider* is a person acting as a chiropractic or osteopathy services provider in the capacity of trustee of a trust and a person occupies a *position of authority* in such a provider if the person is a trustee or beneficiary of the trust.

- (6) For the purposes of this Act, a person occupies a *position of authority* in a body corporate other than a corporate chiropractic or osteopathy services provider if the person—
 - (a) is a director of the body corporate; or
 - (b) exercises, or is in a position to exercise, control or substantial influence over the body corporate in the conduct of its affairs; or
 - (c) where the body corporate is a proprietary company—is a shareholder in the body corporate.
- (7) However—
 - (a) a minor who is a shareholder in a proprietary company, or a beneficiary under a trust, is not, for that reason, to be regarded as a person occupying a *position of authority*; and
 - (b) a charitable organisation that is a beneficiary of a trust is not, for that reason, to be regarded as occupying a *position of authority*.
- (8) For the purposes of this Act, a person who holds more than 10 per cent of the issued share capital of a public company will be regarded as a person occupying a *position of authority* in that company.

4—Medical fitness to provide chiropractic or osteopathy

A person or body must, in making a determination under this Act as to a person's medical fitness to provide chiropractic or osteopathy, have regard to the question of whether the person is able to provide chiropractic or osteopathy personally to a patient without endangering the patient's health or safety.

Part 2—Chiropractic and Osteopathy Board of South Australia

Division 1—Establishment of Board

5—Establishment of Board

- (1) The Chiropractic and Osteopathy Board of South Australia is established.
- (2) The Board—
 - (a) is a body corporate; and
 - (b) has perpetual succession and a common seal; and
 - (c) is capable of suing and being sued in its corporate name; and
 - (d) has all the powers of a natural person that are capable of being exercised by a body corporate; and
 - (e) has the functions and powers assigned or conferred by or under this Act.
- (3) If a document appears to bear the common seal of the Board, it will be presumed, in the absence of proof to the contrary, that the common seal of the Board was duly affixed to the document.

Division 2—Board's membership

6—Composition of Board

- (1)The Board consists of 9 members appointed by the Governor of whom-
 - 4 must be chiropractors chosen at an election (see section 7); and (a)
 - 1 must be an osteopath chosen at an election (see section 7); and (b)
 - 1 must be a legal practitioner nominated by the Minister; and (c)
 - 1 must be a medical practitioner nominated by the Minister; and (d)
 - 2 must be persons nominated by the Minister who are not eligible for (e) appointment under a preceding provision of this subsection.
- At least 1 of the members of the Board must be a woman and 1 must be a man. (2)
 - The Governor may appoint a person to be a deputy of a member and a person so (3) appointed may act as a member of the Board in the absence of the member.
 - (4) The requirements of qualification and nomination (if applicable) made by this section in relation to the appointment of a member extend to the appointment of a deputy of that member

7-Elections and casual vacancies

- An election conducted to choose chiropractors or an osteopath for appointment to the (1)Board must be conducted under the regulations in accordance with principles of proportional representation.
- A person who is a chiropractor at the time the voters roll is prepared in accordance 20 (2)with the regulations for an election to choose chiropractors is entitled to vote at the election.
 - (3) A person who is an osteopath at the time the voters roll is prepared in accordance with the regulations for an election to choose an osteopath is entitled to vote at the election.
 - If an election of a member fails for any reason, the Governor may appoint a (4) chiropractor or osteopath (as the case requires) and the person so appointed will be taken to have been appointed after due election under this section.
 - If a casual vacancy occurs in the office of a member chosen at an election, the (5) following rules govern the appointment of a person to fill the vacancy:
 - if the vacancy occurs within 12 months after the member's election and at that (a) election a candidate or candidates were excluded, the Governor must appoint the person who was the last excluded candidate at that election;
 - if that person is no longer qualified for appointment or is unavailable or (b) unwilling to be appointed or if the vacancy occurs later than 12 months after the member's election, the Governor may appoint a chiropractor or osteopath (as the case requires) nominated by the Minister;
 - before nominating a chiropractor or osteopath for appointment the Minister (c) must consult the representative bodies;

the person appointed holds office for the balance of the term of that person's (d) predecessor.

8—Terms and conditions of membership

- A member of the Board will be appointed on conditions determined by the Governor (1)and for a term, not exceeding 3 years, specified in the instrument of appointment and, at the expiration of a term of appointment, is eligible for reappointment.
- However, a member of the Board may not hold office for consecutive terms that (2)exceed 9 years in total.
- (3) The Governor may remove a member of the Board from office—
 - (a) for breach of, or non-compliance with, a condition of appointment; or
 - (b) for misconduct; or
 - for failure or incapacity to carry out official duties satisfactorily. (c)
- The office of a member of the Board becomes vacant if the member-(4)
 - dies; or (a)
 - completes a term of office and is not reappointed; or (b)
 - resigns by written notice to the Minister; or (c)
 - (d) ceases to satisfy the qualification by virtue of which the member was eligible for appointment to the Board; or
 - is removed from office under subsection (3). (e)
- If a member of the Board is a member constituting the Board for the purposes of any (5) 20 proceedings under Part 4 and the member's term of office expires, or the member resigns, before those proceedings are completed, the member may, for the purpose of continuing and completing those proceedings, continue to act as a member of the Board.

9—Presiding member and deputy 25

The Minister must, after consultation with the Board, appoint a member who is a chiropractor or osteopath (the *presiding member*) to preside at meetings of the Board and another member who is a chiropractor or osteopath (the *deputy presiding member*) to preside at meetings of the Board in the absence of the presiding member.

10—Vacancies or defects in appointment of members 30

An act or proceeding of the Board is not invalid by reason only of a vacancy in its membership or a defect in the appointment of a member.

11—Remuneration

A member of the Board is entitled to remuneration, allowances and expenses determined by the Governor.

Division 3—Registrar and staff of Board

12—Registrar of Board

(1) There will be a Registrar of the Board.

(2) The Registrar will be appointed by the Board on terms and conditions determined by the Board.

13—Other staff of Board

- (1) There will be such other staff of the Board as the Board thinks necessary for the proper performance of its functions.
- (2) A member of the staff of the Board is not, as such, a member of the Public Service, but the Board may employ a person who is on leave from employment in the Public Service or with an instrumentality or agency of the Crown.
- (3) The Board may, with the approval of the Minister administering an administrative unit of the Public Service, make use of the services, facilities or officers of that unit.

Division 4—General functions and powers

14—Functions of Board

- (1) The functions of the Board are as follows:
 - (a) to oversee the practice of chiropractic and osteopathy in the public interest;

- (c) to determine, after consultation with authorities considered appropriate by the Board, the requirements necessary for registration under this Act;
- (d) to establish and maintain the registers contemplated by this Act;
 - (e) to prepare or endorse, subject to the approval of the Minister, codes of conduct or professional standards for registered persons or codes of conduct for chiropractic or osteopathy services providers;
 - (f) to prepare or endorse guidelines on continuing chiropractic or osteopathy education for chiropractors and osteopaths;
 - (g) to establish administrative processes for handling complaints received against registered persons, chiropractic or osteopathy services providers or persons who occupy positions of authority in corporate or trustee chiropractic or osteopathy services providers (which may include processes under which the registered person, provider or person who occupies the position voluntarily enters into an undertaking);
 - (h) to provide advice to the Minister as the Board considers appropriate;
 - (i) to carry out other functions assigned to the Board by or under this Act, or by the Minister.
- 35 (2) The Board must perform its functions under this Act with the object of protecting the health and safety of the public by achieving and maintaining high professional standards both of competence and conduct in the provision of chiropractic and osteopathy in this State.

- (4) The procedures to be observed in relation to the conduct of the business of a committee will be—
 - (a) as determined by the Board; and

(b) insofar as a procedure is not determined under paragraph (a)—as determined by the committee.

16—Delegations

- (1) The Board may delegate any of its functions or powers under this Act other than—
 - (a) this power of delegation; and
 - (b) the power to hear and determine proceedings under Part 4.
- (2) A delegation—
 - (a) may be made—
 - (i) to a member of the Board, the Registrar or an employee of the Board; or
 - (ii) to a committee established by the Board; and
 - (b) may be made subject to conditions and limitations specified in the instrument of delegation; and
 - (c) is revocable at will and does not derogate from the power of the Board to act in a matter.

Division 5—Board's procedures

17—Board's procedures

- (1) Subject to this Act, 5 members constitute a quorum of the Board.
- (2) A meeting of the Board (other than for the purposes of hearing and determining proceedings under Part 4) will be chaired by the presiding member or, in his or her absence, by the deputy presiding member and, in the absence of both the presiding member and the deputy presiding member, the members present at a meeting of the Board must choose 1 of their number to preside at the meeting.
- (3) A decision carried by a majority of the votes cast by members of the Board at a meeting is a decision of the Board.
- (4) Each member present at a meeting of the Board has 1 vote on any question arising for decision and, except in hearing and determining proceedings under Part 4, the member presiding at the meeting may exercise a casting vote if the votes are equal.
- (5) A conference by telephone or other electronic means between the members of the Board will, for the purposes of this section, be taken to be a meeting of the Board at which the participating members are present if—
 - (a) notice of the conference is given to all members in the manner determined by the Board for the purpose; and
 - (b) each participating member is capable of communicating with every other participating member during the conference.
- (6) A proposed resolution of the Board becomes a valid decision of the Board despite the fact that it is not voted on at a meeting of the Board if—
 - (a) notice of the proposed resolution is given to all members of the Board in accordance with procedures determined by the Board; and

- (b) a majority of the members express concurrence in the proposed resolution by letter, telegram, telex, facsimile transmission, electronic mail or other written communication setting out the terms of the resolution.
- (7) However, subsections (5) and (6) do not apply in relation to the hearing and determination of proceedings under Part 4 by the Board as constituted for the purposes of proceedings under that Part.
- (8) The Board must have accurate minutes kept of its meetings.
- (9) Subject to this Act, the Board may determine its own procedures.

18—Conflict of interest etc under Public Sector Management Act

A member of the Board will not be taken to have a direct or indirect interest in a matter for the purposes of the *Public Sector Management Act 1995* by reason only of the fact that the member has an interest in the matter that is shared in common with chiropractors or osteopaths generally or a substantial section of chiropractors or osteopaths in this State.

15 **19—Powers of Board in relation to witnesses etc**

- (1) For the purposes of proceedings before the Board (including an application for registration or reinstatement of registration), the Board may—
 - (a) by summons signed on behalf of the Board by a member of the Board or the Registrar, require the attendance before the Board of a person whom the Board thinks fit to call before it; or
 - (b) by summons signed on behalf of the Board by a member of the Board or the Registrar, require the production of relevant documents, records or equipment and, in the case of a document or record that is not in the English language, require the production of—
 - (i) a written translation of the document or record into English; and
 - (ii) a certificate signed by a translator approved by the Board certifying that the translation accurately reproduces in English the contents of the document or record; or
 - (c) inspect documents, records or equipment produced before it, and retain them for such reasonable period as it thinks fit, and make copies of the documents or records or their contents; or
 - (d) require a person to make an oath or affirmation (which may be administered by a member of the Board) to answer truthfully questions put by a member of the Board or a person appearing before the Board; or
 - (e) require a person appearing before the Board (whether summoned to appear or not) to answer questions put by a member of the Board or by a person appearing before the Board.
- (2) On the receipt of an application for the issue of a summons under this section, a member or the Registrar may, without referring the matter to the Board, issue a summons on behalf of the Board.

- (a) fails without reasonable excuse to comply with a summons issued to attend, or to produce documents, records or equipment, before the Board; or
- (b) having been served with a summons to produce—
 - (i) a written translation of the document or record into English; and
 - (ii) a certificate signed by a translator approved by the Board certifying that the translation accurately reproduces in English the contents of the document or record,

fails, without reasonable excuse, to comply with the summons; or

- (c) misbehaves before the Board, wilfully insults the Board or 1 or more of the members in the exercise of the member's official duties, or wilfully interrupts the proceedings of the Board; or
 - (d) refuses to be sworn or to affirm, or refuses or fails to answer truthfully a relevant question when required to do so by the Board,
- 15 is guilty of an offence.

Maximum penalty: \$10 000 or imprisonment for 6 months.

(4) A person who appears as a witness before the Board has the same protection as a witness in proceedings before the Supreme Court.

20—Principles governing proceedings

- 20 (1) In proceedings before the Board under this Act, the Board—
 - (a) is not bound by the rules of evidence and may inform itself on any matter as it thinks fit; and
 - (b) must act according to equity, good conscience and the substantial merits of the case without regard to technicalities and legal forms.
- 25 (2) In proceedings before the Board under this Act, the Board must keep the parties to the proceedings properly informed as to the progress and outcome of the proceedings.

21—Representation at proceedings before Board

A party to proceedings before the Board (including an applicant for registration or reinstatement of registration) is entitled to be represented at the hearing of those proceedings.

22—Costs

- (1) The Board may award such costs against a party to proceedings before it as the Board considers just and reasonable.
- (2) A party who is dissatisfied with the amount of the costs awarded by the Board may request a Master of the District Court to tax the costs and, after taxing the costs, the Master may confirm or vary the amount of the costs awarded by the Board.
- (3) Costs awarded by the Board under this section may be recovered as a debt.

Division 6—Accounts, audit and annual report

23—Accounts and audit

- (1) The Board must keep proper accounting records in relation to its financial affairs, and must have annual statements of account prepared in respect of each financial year.
- (2) The accounts must be audited at least once in every year by an auditor approved by the Auditor-General and appointed by the Board.
 - (3) The Auditor-General may at any time audit the accounts of the Board.

24—Annual report

- (1) The Board must, on or before 30 September in each year, deliver to the Minister a report on the administration of this Act and the work of the Board during the financial year ending on the preceding 30 June.
 - (2) The report must—
 - (a) include the following information in relation to the relevant financial year:
 - (i) the number and nature of complaints received by the Board against registered persons, chiropractic or osteopathy services providers and persons who occupy positions of authority in corporate or trustee chiropractic or osteopathy services providers;
 - (ii) the number and nature of voluntary undertakings given to the Board by registered persons, chiropractic or osteopathy services providers and persons who occupy positions of authority in chiropractic or osteopathy services providers;
 - (iii) the outcomes of proceedings before the Board under Part 4;
 - (iv) information prescribed by the regulations; and
 - (b) incorporate the audited accounts of the Board for the relevant financial year.
- 25 (3) The Minister must, within 12 sitting days after receiving a report under this section, have copies of the report laid before both Houses of Parliament.

Part 3—Registration and practice

Division 1—Registers

25—Registers

- (1) The Registrar must keep the following registers:
 - (a) a chiropractic student register;
 - (b) an osteopathy student register;
 - (c) a register of chiropractors;
 - (d) a register of osteopaths;

26—Authority conferred by registration

Subject to any restrictions, limitations or conditions imposed under this Act-

- (a) registration on the chiropractic student register authorises the person to provide chiropractic in prescribed circumstances; and
- (b) registration on the osteopathy student register authorises the person to provide osteopathy in prescribed circumstances; and
- (c) registration on the register of chiropractors authorises the person to provide chiropractic; and
- (d) registration on the register of osteopaths authorises the person to provide osteopathy.

Division 2—Registration

27—Registration of natural persons as chiropractors or osteopaths

- (1) Subject to this Act, a natural person is eligible for registration on the register of chiropractors or the register of osteopaths if the person, on application to the Board, satisfies the Board that he or she—
 - (a) has qualifications approved or recognised by the Board for the purposes of registration on that register; and
 - (b) has met the requirements determined by the Board to be necessary for the purposes of registration on that register; and
 - (c) is medically fit to provide chiropractic or osteopathy of the kind authorised by registration on that register; and
 - (d) is, unless exempted by the Board, insured or indemnified in a manner and to an extent approved by the Board against civil liabilities that might be incurred by the person in connection with the provision of chiropractic or osteopathy as a chiropractor or osteopath or proceedings under Part 4 against the person; and
 - (e) is a fit and proper person to be registered on that register.
- (2) If a person who applies for registration, or reinstatement of registration, on the register of chiropractors or the register of osteopaths—
 - (a) does not, in the opinion of the Board, have the necessary qualifications or experience required for registration on that register; or
 - (b) is not, in the opinion of the Board, medically fit to provide chiropractic or osteopathy of the kind authorised by registration on that register; or
 - (c) is not, in the opinion of the Board, a fit and proper person to be registered on that register,

the Board may register the person on the register in pursuance of this subsection (*limited registration*)—

- (d) in order to enable the person—

 - a condition limiting the period during which the registration will have effect; (b)
 - a condition requiring that the person be supervised in the provision of (c) chiropractic or osteopathy by a particular person or by a person of a particular class:
 - such other conditions as the Board thinks fit. (d)

29—Application for registration and provisional registration

- (1) An application for registration must—
 - (a) be made to the Board in the manner and form approved by the Board; and
 - (b) be accompanied by the registration fee fixed under this Act.
- An applicant for registration must, if the Board so requires provide the Board with (2)specified information to enable the Board to determine the application.
 - The Board may require an applicant for registration— (3)
 - (a) to submit a medical report or other evidence acceptable to the Board as to the applicant's medical fitness to provide chiropractic or osteopathy; or
 - to obtain additional qualifications or experience specified by the Board before (b) the Board determines the application.
 - If it appears likely to the Registrar that the Board will grant an application for (4) registration, the Registrar may provisionally register the applicant (provisional registration).
- (5) Provisional registration remains in force until the Board determines the application.
 - The registration by the Board under this Act of a person who was provisionally (6) registered has effect from the commencement of the provisional registration.

30—Removal from register

The Registrar must, on application by a registered person, remove the person from the (1)register to which the application relates.

- 20 (d) on account of the person—
 - (i) ceasing to hold a qualification required for registration on that register or otherwise ceasing to be entitled to be registered on that register; or
 - (ii) ceasing to be enrolled in the course of study that formed the basis for the person's registration on the chiropractic student register or osteopathy student register,

may apply to the Board at any time for reinstatement on that register.

- (2) A person whose registration on a register has been suspended may apply to the Board for reinstatement on that register (but not, in the case of an order for suspension for a specified period, until after the expiry of that period).
- (3) A person who has been disqualified from being registered on a register under this Act may, subject to the terms of the order for disqualification, apply to the Board for reinstatement on that register.
- (4) An application for reinstatement must—

- (5) An applicant for reinstatement must, if the Board so requires provide the Board with specified information to enable the Board to determine the application.

- (8) The Board may refuse to reinstate the applicant on the appropriate register until all complaints (if any) laid against the applicant under this Act have been finally disposed of.

32—Fees and returns

- (1) Subject to this Act, a person will not be registered, nor will a registration be reinstated, until the registration or reinstatement fee, and the annual practice fee, fixed under this Act have been paid.
- (2) A registered person must, in each calendar year before the date fixed for that purpose by the Board—
 - (a) pay to the Board the annual practice fee fixed under this Act; and
 - (b) furnish the Board with a return, in a form approved by the Board, containing all information specified in the return relating to the provision of chiropractic or osteopathy, or the undertaking of any course of continuing chiropractic or osteopathy education, by the person during the preceding year or to any other matter relevant to the person's registration under this Act.
- (3) The Board may, without further notice, remove from the appropriate register a person who fails to pay the annual practice fee or furnish the required return by the due date.

Division 3—Special provisions relating to chiropractic or osteopathy services providers

33—Information to be given to Board by chiropractic or osteopathy services providers

- (1) A chiropractic or osteopathy services provider must—
 - (a) in the case of a person who was such a provider immediately before the commencement of this section—within 60 days of that commencement; and

34—Illegal holding out as registered person

(1) A person must not hold himself or herself out as a registered chiropractic student, registered osteopathy student, chiropractor or osteopath or permit another person to do so unless registered on the appropriate register.

Maximum penalty: \$50 000 or imprisonment for 6 months.

- (2) A person must not hold out another as a registered chiropractic student, registered osteopathy student, chiropractor or osteopath unless the other person is registered on the appropriate register.

35—Illegal holding out concerning limitations or conditions

- (1) A person whose registration is limited or subject to a condition under this Act must not hold himself or herself out as having a registration that is not limited or not subject to a condition or permit another person to do so.

- (d) in relation to registration on the register of osteopaths—
 - (i) osteopath; or
 - (ii) manipulative therapist; or

- (e) any other word or expression prescribed by the regulations.
- (4) However, this section does not prevent the title "manipulative therapist" or "spinal therapist" being used by or in relation to a person registered as a physiotherapist under the *Physiotherapy Practice Act 2005*.

37—Restrictions on provision of chiropractic or osteopathy by unqualified persons

- 25 (1) A person must not provide restricted therapy unless—
 - (a) the person is a qualified person; or
 - (b) the person provides that therapy through the instrumentality of a qualified person.

Maximum penalty: \$50 000 or imprisonment for 6 months.

- (2) Subsection (1) does not apply in relation to restricted therapy provided by an unqualified person in prescribed circumstances or pursuant to an exemption under subsection (3).
 - (3) The Governor may, by proclamation, exempt a person from subsection (1) if of the opinion that good reason exists for doing so in the particular circumstances of the case.
 - (4) An exemption under subsection (3) may be subject to such conditions as the Governor thinks fit and specifies in the proclamation.

38—Board's approval required where chiropractor, osteopath, chiropractic student or osteopathy student has not practised for 5 years

Division 1—Preliminary

39—Interpretation

 - (a) the provider has contravened or failed to comply with a provision of this Act; or
 - (b) there has been, in connection with the provision of chiropractic or osteopathy by the provider, a contravention or failure to comply with a code of conduct under this Act applying to the provider; or
 - (c) the provider or any person employed or engaged by the provider has, in connection with the provision of chiropractic or osteopathy by the provider, engaged in conduct that would, if the person were a registered person, constitute unprofessional conduct; or
 - (d) the provider is for any reason not a fit and proper person to be a chiropractic or osteopathy services provider; or
 - (e) in the case of a corporate or trustee chiropractic or osteopathy services provider, an occupier of a position of authority in the provider—
 - (i) has contravened or failed to comply with a provision of this Act; or
 - (ii) has, in connection with the provision of chiropractic or osteopathy by the provider, engaged in conduct that would, if the person were a registered person, constitute unprofessional conduct; or
 - (iii) is for any reason not a fit and proper person to occupy a position of authority in a corporate or trustee chiropractic or osteopathy services provider.
 - (3) There is proper cause for disciplinary action against the occupier of a position of authority in a corporate or trustee chiropractic or osteopathy services provider if—
 - (a) the person has contravened or failed to comply with a provision of this Act; or
 - (b) the person has, in connection with the provision of chiropractic or osteopathy by the provider, engaged in conduct that would, if the person were a registered person, constitute unprofessional conduct; or
 - (c) the person is for any reason not a fit and proper person to occupy a position of authority in a corporate or trustee chiropractic or osteopathy services provider; or

Division 2—Investigations

41—Powers of inspectors

 - (b) that a chiropractor, osteopath, chiropractic student or osteopathy student is medically unfit to provide chiropractic or osteopathy, as the case may be; or

 - an inspector may investigate the matter.
 - (2) For the purposes of an investigation, an inspector may—
 - (a) at any reasonable time, enter and inspect premises of a registered person or premises on which the inspector reasonably suspects an offence against this Act has been or is being committed; or
 - (b) with the authority of a warrant issued by a magistrate or in circumstances in which the inspector reasonably believes that immediate action is required, use reasonable force to break into or open any part of, or anything in or on any premises referred to in paragraph (a); or
 - (c) while on premises entered under paragraph (a) or (b), seize and retain anything found on the premises that the inspector reasonably believes may afford evidence relevant to the matters under investigation; or
 - (d) require any person who has possession of documents or records relevant to the matters under investigation to produce those documents or records for inspection, including written records that reproduce in a readily understandable form information kept by computer, microfilm or other process; or
 - (e) inspect any documents or records produced to the inspector and retain them for such reasonable period as the inspector thinks fit, and make copies of the records or documents; or

- (f) require any person who is in a position to provide information relevant to the matters under investigation to answer any question put by the inspector in relation to those matters; or
- (g) take photographs, films or video or audio recordings; or
- (h) if the inspector reasonably suspects that an offence against this Act has been or is being committed, require the suspected offender to state his or her full name and address.
- (3) An inspector must not exercise the power conferred by subsection (2)(a) in relation to residential premises except with the permission of the occupier of the premises or on the authority of a warrant issued by a magistrate.
- (4) A magistrate must not issue a warrant under this section unless satisfied, by information given on oath, that the warrant is reasonably required in the circumstances.
- (5) The person in charge of premises at the relevant time must give an inspector such assistance and provide such facilities as are necessary to enable the powers conferred by this section to be exercised.

Maximum penalty: \$5 000.

42—Offence to hinder etc inspector

A person who-

- (a) hinders or obstructs an inspector in the exercise of powers conferred by this Act; or
- (b) uses abusive, threatening or insulting language to an inspector; or
- (c) refuses or fails to comply with a requirement of an inspector under this Act; or
- (d) when required by an inspector to answer a question, refuses or fails to answer the question to the best of the person's knowledge, information and belief; or
- (e) falsely represents, by words or conduct, that he or she is an inspector,

 - (b) require the respondent to pay to the Board a fine not exceeding \$10 000;
 - (c) if the respondent is a registered person—
 - (i) impose conditions on the respondent's registration restricting the respondent's right to provide chiropractic or osteopathy;
 - (ii) suspend the respondent's registration for a period not exceeding 1 year;
 - (iii) cancel the respondent's registration;
 - (iv) disqualify the respondent from being registered;
 - (d) prohibit the respondent from carrying on business as a chiropractic or osteopathy services provider;
 - (e) prohibit the respondent from occupying a position of authority in a corporate or trustee chiropractic or osteopathy services provider.
 - (5) The Board may—
 - (a) stipulate that a disqualification or prohibition under subsection (4) is to apply—

- (5) A person who is aggrieved by the conduct of a person that is the subject-matter of proceedings before the Board under this Part is, subject to any direction of the Board to the contrary, entitled to be present at the hearing of the proceedings.
- (6) In the course of proceedings before the Board under this Part, the Board may—
 - (a) receive in evidence a transcript of evidence taken in proceedings before a court, tribunal or other body constituted under the law of South Australia or of any other State or a Territory of Australia or of another country, and draw any conclusions of fact from the evidence that it considers proper;
 - (b) adopt, as in its discretion it considers proper, any findings, decision, judgment, or reasons for judgment, of any such court, tribunal or body that may be relevant to the proceedings.
- (7) The Board should conduct proceedings under this Part as expeditiously as possible.

Part 5—Appeals

51—Right of appeal to District Court

66—Victimisation

- (1) A person commits an act of victimisation against another person (the *victim*) if he or she causes detriment to the victim on the ground, or substantially on the ground, that the victim—
 - (a) has disclosed or intends to disclose information; or

- (3) Where a complaint alleging an act of victimisation under this Act has been lodged with the Commissioner for Equal Opportunity and the Commissioner is of the opinion that the subject matter of the complaint has already been adequately dealt with by a competent authority, the Commissioner may decline to act on the complaint or to proceed further with action on the complaint.
 - (4) In this section—

detriment includes-

- (a) injury, damage or loss; or
- (b) intimidation or harassment; or
- (c) discrimination, disadvantage or adverse treatment in relation to the victim's employment or business; or
- (d) threats of reprisal.

67—Self-incrimination

If a person is required to provide information or to produce a document, record or equipment under this Act and the information, document, record or equipment would tend to incriminate the person or make the person liable to a penalty, the person must nevertheless provide the information or produce the document, record or equipment, but the information, document, record or equipment so provided or produced will not be admissible in evidence against the person in proceedings for an offence, other than an offence against this or any other Act relating to the provision of false or misleading information.

68—Punishment of conduct that constitutes an offence

 - (2) Without limiting the effect of subsection (1), a notice or other document required or authorised to be given or sent to, or served on, a person for the purposes of this Act may, if the person is a company or registered body within the meaning of the *Corporations Act 2001* of the Commonwealth, be served on the person in accordance with that Act.

75—Evidentiary provision

- (1) In proceedings for an offence against this Act or in disciplinary proceedings under Part 4, an allegation in the complaint—
 - (a) that a person named in the complaint is or is not, or was or was not on a specified date, a qualified person;
 - (b) that a person named in the complaint is or is not, or was or was not on a specified date, registered on the register of chiropractors, register of osteopaths, chiropractic student register or osteopathy student register;
 - (c) that the registration of a person named in the complaint is, or was on a specified date, subject to specified conditions;
 - (d) that a person named in the complaint is, or was on a specified date, a chiropractic or osteopathy services provider or an exempt provider;
 - (e) that a person named in the complaint is, or was on a specified date, occupying a position of authority in a corporate or trustee chiropractic or osteopathy services provider;
 - (f) that a person named in the complaint is, or was on a specified date, an inspector,

must be accepted as proved in the absence of proof to the contrary.

(2) In legal proceedings, a document apparently certified by the Registrar to be a copy of a register under this Act, or a copy of a code of conduct or professional standard prepared or endorsed by the Board under this Act, must be accepted as such in the absence of proof to the contrary.

76—Regulations

- (1) The Governor may make such regulations as are contemplated by, or necessary or expedient for the purposes of, this Act.
- (2) Without limiting the generality of subsection (1), the regulations may—
 - (a) declare specified physical therapy to be chiropractic or oestopathy;
 - (b) prescribe, or empower the Board to fix—
 - (i) fees or charges for the purposes of this Act;
 - (ii) fees or charges for services provided by the Board in the exercise of its functions under this Act,

and may provide for the recovery of a fee or charge so prescribed;

- (c) exempt any person or class of persons from the obligation to pay a fee or charge so prescribed;
- (d) regulate, or otherwise make provision with respect to, the education of chiropractors or osteopaths for the purposes of this Act, including by making provision with respect to the approval of courses that may lead to registration;
- (e) make any provision with respect to the keeping of a register;
- (f) prescribe penalties, not exceeding \$5 000, for breach of, or non-compliance, with a regulation.

(3) The regulations may—

- (a) refer to or incorporate, wholly or partially and with or without modification, a code, standard or other document prepared or published by a prescribed body, either as in force at the time the regulations are made or as in force from time to time; and
- (b) be of general or limited application; and
- (c) make different provision according to the persons, things or circumstances to which they are expressed to apply; and
- (d) provide that a specified provision of this Act does not apply, or applies with prescribed variations, to any person, circumstance or situation (or person, circumstance or situation of a prescribed class) specified by the regulations, subject to any condition to which the regulations are expressed to be subject; and
- (e) provide that any matter or thing is to be determined, dispensed with, regulated or prohibited according to the discretion of the Minister, the Board or another prescribed authority.
- (4) If a code, standard or other document is referred to or incorporated in the regulations—
 - (a) a copy of the code, standard or other document must be kept available for public inspection, without charge and during ordinary office hours, at an office or offices specified in the regulations; and
 - (b) evidence of the contents of the code, standard or other document may be given in any legal proceedings by production of a document apparently certified by the Minister to be a true copy of the code, standard or other document.

Schedule 1—Repeal and transitional provisions

Part 1—Repeal of Chiropractors Act 1991

1—Repeal of Act

The Chiropractors Act 1991 is repealed.

30 Part 2—Transitional provisions

2—Transitional provisions relating to Board

- (1) The Chiropractic and Osteopathy Board of South Australia is the same body corporate as the Chiropractors Board of South Australia continued in existence under the repealed Act.
- (2) On the commencement of this clause, all members of the Board then in office vacate their respective offices so that fresh appointments may be made to the Board under this Act.
 - (3) Despite section 6, the first appointment under subsection (1)(b) will be of a person nominated by the Minister as a suitable person to represent the interests of osteopaths.

- (4) If appointments are to be made to the Board pursuant to the *Acts Interpretation Act 1915* prior to the commencement and for the purposes of section 6—
 - (a) a reference in that section to *chiropractor* will, for those purposes, be taken to be a reference to a person who is a registered chiropractor under the repealed Act at the relevant time; and
 - (b) despite section 14C(3) of the *Acts Interpretation Act 1915*, such an appointment takes effect on the commencement of section 6 and not before.

3—Transitional provisions relating to registration

- (1) The register maintained under the repealed Act continues in existence as the register of chiropractors under this Act.
- (2) The Registrar will, on the commencement of this Act, remove from the register any company that was registered as a chiropractor under the repealed Act.
- (3) A person who is registered on the register of chiropractors immediately following the commencement of this clause will be taken to be registered under this Act on that register and any restrictions, limitations or conditions that applied to the registration of the person under the repealed Act immediately before that commencement will be taken to continue to apply to the registration of the person under this Act as if they had been imposed by the Board under this Act.
- (4) If a person referred to in subclause (3) makes due application within 3 months of the commencement of this clause for—
 - (a) registration on the register of osteopaths; or
 - (b) removal from the register of chiropractors and registration on the register of osteopaths,

the Board must, if satisfied as to the matters set out in section 27(1)(a) to (d), grant the application.

- (5) No fees are payable in respect of an application under subclause (4).
- (6) If a person who was removed from the register under the repealed Act for any reason and who had not, before the commencement of this Act, been reinstated on that register, applies for registration under this Act, the Board may deal with the application as though it were an application for reinstatement on the register of chiropractors under this Act.

4-Regulations

The regulations may make other provisions of a savings or transitional nature consequent on the enactment of this Act.

Schedule 2—Further provisions relating to Board

1—Duty of members of Board with respect to conflict of interest

- (1) A member of the Board who has a direct or indirect personal or pecuniary interest in a matter decided or under consideration by the Board—
 - (a) must, as soon as reasonably practicable, disclose in writing to the Board full and accurate details of the interest; and

- (c) must not vote in relation to that matter; and
- (d) must be absent from the meeting room when any such discussion or voting is taking place.

Maximum penalty: \$20 000.

- (2) If a member of the Board makes a disclosure of interest and complies with the other requirements of subclause (1) in respect of a proposed contract—
 - (a) the contract is not liable to be avoided by the Board; and
 - (b) the member is not liable to account to the Board for profits derived from the contract.
- (3) If a member of the Board fails to make a disclosure of interest or fails to comply with any other requirement of subclause (1) in respect of a proposed contract, the contract is liable to be avoided by the Board or the Minister.
- (4) A contract may not be avoided under subclause (3) if a person has acquired an interest in property the subject of the contract in good faith for valuable consideration and without notice of the contravention.
 - (5) Where a member of the Board has or acquires a personal or pecuniary interest, or is or becomes the holder of an office, such that it is reasonably foreseeable that a conflict might arise with his or her duties as a member of the Board, the member must, as soon as reasonably practicable, disclose in writing to the Board full and accurate details of the interest or office.

Maximum penalty: \$20 000.

- (6) A disclosure under this clause must be recorded in the minutes of the Board and reported to the Minister.
- (7) If, in the opinion of the Minister, a particular interest or office of a member of the Board is of such significance that the holding of the interest or office is not consistent with the proper discharge of the duties of the member, the Minister may require the member either to divest himself or herself of the interest or office or to resign from the Board (and non-compliance with the requirement constitutes misconduct and hence a ground for removal of the member from the Board).
 - (8) Without limiting the effect of this clause, a member of the Board will be taken to have an interest in a matter for the purposes of this clause if an associate of the member has an interest in the matter.
 - (9) This clause does not apply in relation to a matter in which a member of the Board has an interest while the member remains unaware that he or she has an interest in the matter, but in any proceedings against the member the burden will lie on the member to prove that he or she was not, at the material time, aware of his or her interest.
 - (10) In this clause—

associate has the same meaning as in the Public Corporations Act 1993.

40 **2—Protection from personal liability**

- (1) No personal liability is incurred for an act or omission by—
 - (a) a member of the Board; or

- (b) a member of a committee of the Board; or
- (c) the Registrar of the Board; or
- (d) any other person engaged in the administration of this Act,

in good faith in the performance or purported performance of functions or duties under this Act.

(2) A civil liability that would, but for subclause (1), lie against a person, lies instead against the Crown.

3—Expiry of Schedule

This Schedule will expire on the commencement of section 6H of the *Public Sector Management Act 1995* (as inserted by the *Statutes Amendment (Honesty and Accountability in Government) Act 2003*), or if that section has come into operation before the commencement of this clause, will be taken not to have been enacted.
