# **Kidnapping Act 1960**

### The Parliament of South Australia enacts as follows:

#### 1—Short title

This Act may be cited as the *Kidnapping Act 1960*.

# 2—Kidnapping

- (1) Any person who, whether for ransom, reward, service or for any similar purpose, unlawfully leads, takes, decoys, inveigles or entices away, abducts, seizes, carries off or detains any person without his consent or with his consent obtained by fraud or duress to the intent that or whereby such person may be or is held, confined or imprisoned or prevented from returning to his normal place of abode or sent or taken out of the State shall be guilty of an offence and liable to be imprisoned for life.
- (2) A person under the age of eighteen years shall be deemed incapable of consenting to being led, taken, decoyed, inveigled or enticed away, abducted, seized, carried off, detained, held confined or imprisoned.
