1. These regulations may be cited as the *Auditor-General Prescribed Incorporated Hospital and Health Centre Regulations, 1982*.

2. The hospitals in the first schedule, being incorporated hospitals established pursuant to Part III of the Act, are prescribed hospitals for the purposes of section 34 of the Act.

3. The health centres in The Second Schedule, being incorporated health centres established pursuant to Part IV of the Act, are prescribed health centres for the purposes of Section 55 of the Act.
