REGULATIONS UNDER THE BUSINESS NAMES ACT 1996

Business Names Regulations 1996

Citation

1. These regulations may be cited as the *Business Names Regulations 1996*.

Commencement

2. These regulations will come into operation on the day on which the *Business Names Act 1996* comes into operation.

Revocation

3. The *Business Names Regulations 1964* (see *Gazette* 21 May 1964 p. 1068), as varied, are revoked.

Interpretation

4. In these regulations, unless the contrary intention appears—

"Act" means the *Business Names Act 1996*.

Fees

5. (1) The fees fixed by the schedule are payable to the Commission for the purposes set out in the schedule.

(2) The Commission may waive, reduce or refund a fee (or part of a fee) payable under these regulations if satisfied that it is appropriate to do so in a particular case.
