Citation

1. These regulations may be cited as the Business Names Regulations 1996.

Commencement

2. These regulations will come into operation on the day on which the *Business Names Act* 1996 comes into operation.

3. The Business Names Regulations 1964 (see Gazette 21 May 1964 p. 1068), as varied, are revoked.

Interpretation

4. In these regulations, unless the contrary intention appears-

"Act" means the Business Names Act 1996.

5. (1) The fees fixed by the schedule are payable to the Commission for the purposes set out in the schedule.

(2) The Commission may waive, reduce or refund a fee (or part of a fee) payable under these regulations if satisfied that it is appropriate to do so in a particular case.
