Legislative history

1—Short title

These regulations may be cited as the *Business Names Regulations 1996*.

2—Commencement

These regulations will come into operation on the day on which the *Business Names Act 1996* comes into operation.

3—Revocation

The *Business Names Regulations 1964* (see *Gazette 21.5.1964 p1068*), as varied, are revoked.

4—Interpretation

In these regulations, unless the contrary intention appears—
Act means the *Business Names Act 1996*.

5—Fees

- (1) The fees fixed by the Schedule are payable to the Commission for the purposes set out in the Schedule.
- (2) The Commission may waive, reduce or refund a fee (or part of a fee) payable under these regulations if satisfied that it is appropriate to do so in a particular case.
