Legislative history

1—Short title

These regulations may be cited as the *Children's Services (Baby Sitting Agencies) Regulations 2001*.

2—Commencement

These regulations will come into operation on 1 September 2001.

3—Revocation

The *Children's Services Act (Baby Sitting Agencies) Regulations 1985* (see *Gazette 12.9.1985 p805*) are revoked.

4—Interpretation

In these regulations unless the contrary intention appears—

Act means the *Children's Services Act 1985*.

5—Licences (section 30)

- (1) An application for a licence or renewal of a licence to carry on the business of a baby sitting agency must be in the form set out in form 1 of the Schedule.
- (2) An application for renewal of a licence must be lodged with the Director at least 14 days before the expiry of the licence.
- (3) On receipt of an application for a licence or renewal of a licence, the Director may, for the purposes of section 30 of the Act, issue a licence in the form set out in form 2 of the Schedule.

6—Prescribed records (section 32)

For the purposes of section 32 of the Act, the following are prescribed records to be maintained by a licensed baby sitting agency in relation to each person employed or introduced in the course of its business as a baby sitting agency:

- (a) the person's name, address and telephone number (if any);
- (b) names and addresses of referees who have provided information about the person's character and competence;
- (c) details of the person's relevant training and qualifications;
- (d) in respect of each baby sitting assignment undertaken by the person, the date of the assignment and the name and address of the person for whom the assignment was undertaken.
