#### Citation

**1.** These regulations may be cited as the *Road Traffic (Section 47I Hospitals) Regulations* 1992.

#### Commencement

2. These regulations will come into operation on 1 September 1992.

#### Revocation

**3.** The *Road Traffic (Blood Analysis) Regulations 1973* (see *Gazette* 19 July 1973 p. 299), as varied, are revoked.

### Interpretation

4. In these regulations—

"the Act" means the Road Traffic Act 1961.
