1—Short title

These regulations may be cited as the *Strata Titles (Fees) Regulations 2001*.

4—Interpretation

In these regulations, unless the contrary intention appears—
the Act means the *Strata Titles Act 1988*.

5—Fees

The fees set out in Schedule 1 are payable to the Registrar-General in respect of the matters referred to in Schedule 1.
