REGULATIONS UNDER THE UNCLAIMED GOODS ACT 1987

Unclaimed Goods Regulations 1998

being

No. 214 of 1998: *Gaz.* 17 December 1998, p. 1974¹

Citation

1. These regulations may be cited as the *Unclaimed Goods Regulations 1998*.

Commencement

2. These regulations come into operation on the day on which they are made.

Revocation

3. The *Unclaimed Goods Regulations 1987* (see *Gazette* 30.7.87 p. 295) are revoked.

Interpretation

4. In these regulations—

"**the Act**" means the *Unclaimed Goods Act 1987*.

Variation of values in definitions of "scale 1", "scale 2" and "scale 3"

5. (1) The value of \$100 referred to in the definitions of "**scale 1**" and "**scale 2**" in section 3(1) of the Act is varied to \$200.

(2) The value of \$500 referred to in the definitions of "**scale 2**" and "**scale 3**" in section 3(1) of the Act is varied to \$1 000.

Forms

6. (1) A notice for the purposes of section 5(2)(d)(ii) of the Act must be in the form set out in Schedule 1.

(2) A notice for the purposes of section 6(5)(b) of the Act must be in the form set out in Schedule 2.
