Public Sector Management (Shared Services SA (12)) Proclamation 2009

under section 7 of the *Public Sector Management Act 1995*

1—Short title

This proclamation may be cited as the *Public Sector Management (Shared Services SA (12)) Proclamation 2009*.

2—Commencement

This proclamation will come into operation on 9 June 2009.

3—Transfer of employees to Department of Treasury and Finance (for Shared Services SA)

- (1) The employees referred to in Schedule 1 are transferred from the Department of Education and Children's Services to the Department of Treasury and Finance.
- (2) The employees referred to in Schedule 2 are transferred from the Department for Environment and Heritage to the Department of Treasury and Finance.
- (3) The employees referred to in Schedule 3 are transferred from the Department for Families and Communities to the Department of Treasury and Finance.
- (4) The employees referred to in Schedule 4 are transferred from the Department of the Premier and Cabinet to the Department of Treasury and Finance.
- (5) The employees referred to in Schedule 5 are transferred from the Department of Primary Industries and Resources to the Department of Treasury and Finance.
- (6) If an employee whose employment is subject to a contract under section 34 or 40 of the *Public Sector Management Act 1995* is transferred to the Department of Treasury and Finance under this clause, the provisions of the contract will continue to apply in relation to the employee's employment in the Department as if the contract had been entered into between the employee and the Chief Executive of the Department, subject to any necessary modifications or further agreement between the employee and the Chief Executive.
