National Parks and Wildlife (General Reserves Trust) Variation Proclamation 2010

under section 45B of the National Parks and Wildlife Act 1972

Preamble

- 1 The General Reserves Trust was established by proclamation pursuant to section 45B(1) of the *National Parks and Wildlife Act 1972* on 30 November 1978 (see *Gazette 30.11.1978 p2096*).
- 2 Pursuant to section 45B(3) of the Act, the proclamation has been varied by subsequent proclamations (see—
 - (a) *Gazette 25.06.1987 p1610*;
 - (b) *Gazette 19.09.1991 p848*;
 - (c) *Gazette* 02.08.1997 p478;
 - (d) *Gazette 19.06.1997 p3002*;
 - (e) *Gazette* 20.07.2000 p164).

Note—

The notices referred to in paragraphs (a), (c) and (e) varied the reserves in relation to the Trust, the notice referred to in paragraph (b) reduced the quorum required by the Trust and the notice referred to in paragraph (d) made a number of variations in relation to the governance of the Trust.

3 It is now appropriate to further vary the proclamation as varied by the proclamations referred in clause 2 of this preamble.

Part 1—Preliminary

1—Short title

This proclamation may be cited as the *National Parks and Wildlife (General Reserves Trust) Variation Proclamation 2010.*

2—Commencement

This proclamation comes into operation on the day on which it is made.

3—Variation provisions

In this proclamation, a provision under a heading referring to the variation of a specified proclamation varies the proclamation so specified.

4—Interpretation

In this proclamation—

Act means the National Parks and Wildlife Act 1972;

General Reserves Trust proclamation means the proclamation under section 45B of the Act establishing the General Reserves Trust, published in the Gazette on 30 November 1978 (see *Gazette 30.11.1978 p2096*).

Part 2—Variation of General Reserves Trust proclamation

5—Variation of General Reserves Trust proclamation

- (1) Before paragraph (1) insert:
 - (a1) This proclamation may be cited as the *National Parks and Wildlife* (*General Reserves Trust*) *Proclamation 1978*.
- (2) Paragraph (3)—delete "five" and substitute:

- (3) After paragraph (3) insert:
 - (3a) At least 1 member of the Trust must be a man and 1 must be a woman (and, in appointing members to the Trust, the Minister should, as far as is reasonable, endeavour to achieve a gender balance on the Trust);
- (4) Paragraph (5)(a)—delete "two" and substitute:
