Forestry (Forest Reserve—Northern Forest District) Amendment Proclamation 2022

under section 3(3) of the *Forestry Act 1950*

Preamble

- 1 The following land is forest reserve under the *Forestry Act 1950* (see proclamation, *Gazette 19.3.1992 p877*, as amended) and forms part of the Northern Forest District:
 - Portion of Section 399, Hundred of Belalie (now identified as Allotment 12 in Deposited Plan 117977);
 - Allotment 2 of Plan No. DP 52649 accepted for deposit in the Lands Titles Registration Office at Adelaide;
 - Portion of Section 23, Hundred of Darling (now identified as Allotment 18 in Deposited Plan 122753);
 - Portion of Section 23, Hundred of Darling (being the balance of that Section), Sections 24, 47, 275, 283, 285 and 289, Hundred of Darling, and Allotment 7 in approved plan No. D117159 lodged in the Lands Titles Registration Office at Adelaide (all now identified as Allotments 11, 12, 13, 14, 15, 16 and 17 in Deposited Plan 122753);
 - Sections 36, 40, 43—45, 50, 51, 291, 292, 296, 297, 309—312, 315 and 327, Hundred of Darling;
 - Allotment 4 in approved plan No. D117158 lodged in the Lands Titles Registration Office at Adelaide;
 - Allotment comprising Pieces 4, 5, 6, 7 and 8 in approved plan No. D118198 lodged in the Lands Titles Registration Office at Adelaide;
 - Allotment comprising Pieces 9, 10 and 11 in approved plan No. D118198 lodged in the Lands Titles Registration Office at Adelaide;
 - Section 16, Hundred of Howe;
 - Allotment 9 in approved plan No. D117159 lodged in the Lands Titles Registration Office at Adelaide (now identified as Allotments 19 and 20 in Deposited Plan 122769).
- 2 It is now intended that the land described in clause 1 cease to be forest reserve.

Part 1—Preliminary

1—Short title

This proclamation may be cited as the *Forestry (Forest Reserve—Northern Forest District) Amendment Proclamation 2022*.

2—Commencement

This proclamation comes into operation at midday on the fourteenth day after the day on which it is made.
