Schedule—Plan of long term dry area

Part 1—Preliminary

1—Short title

These regulations may be cited as the *Liquor Licensing (Dry Areas—Long Term) Variation Regulations 2003*.

2—Commencement

These regulations come into operation on the day on which they are made.

3—Variation provisions

In these regulations, a provision under a heading referring to the variation of specified regulations varies the regulations so specified.

4—Variation of Schedule 1—Long term dry areas

(1) Schedule 1, item headed "Aberfoyle Park—Area 1", column headed "Extent of Prohibition"—delete "The consumption of liquor is prohibited" and substitute:

The consumption and possession of liquor are prohibited

(2) Schedule 1, item headed "Christies Beach—Area 1", column headed "Extent of prohibition"—delete "The consumption of liquor is prohibited" and substitute:

The consumption and possession of liquor are prohibited

(3) Schedule 1, item headed "Moana—Area 1", column headed "Extent of prohibition"—delete "The consumption of liquor is prohibited" and substitute:

The consumption and possession of liquor are prohibited

(4) Schedule 1, item headed "Moana—Area 2", column headed "Extent of prohibition"—delete "The consumption of liquor is prohibited" and substitute:

The consumption and possession of liquor are prohibited

(5) Schedule 1, item headed "Morphett Vale—Area 1", column headed "Extent of prohibition"—delete "The consumption of liquor is prohibited" and substitute:

The consumption and possession of liquor are prohibited

(6) Schedule 1, item headed "Noarlunga Centre—Area 1", column headed "Extent of prohibition"—delete "The consumption of liquor is prohibited" and substitute:

The consumption and possession of liquor are prohibited

(7) Schedule 1, item headed "**Port Noarlunga—Area 1**", column headed "*Extent of prohibition*"—delete "The consumption of liquor is prohibited" and substitute:

The consumption and possession of liquor are prohibited

(8) Schedule 1—after item headed "Port Noarlunga—Area 1" insert:

Port Noarlunga—Area 2

(see Schedule 2: Port Noarlunga—Plan No 1, area 2)

Area Period Extent of prohibition

The area at Port Noarlunga known as the Jubilee Park Reserve (together with adjacent land) bounded as follows: commencing at the point at which the low water mark on the southern side of the Onkaparinga River intersects the eastern side of the Saltfleet Street Bridge, then generally south-easterly along that side of the Bridge and along the eastern boundary of Saltfleet Street to the point at which the eastern boundary of Saltfleet Street meets the northern boundary of Britain Drive, then easterly in a straight line to the low water mark on the western side of the Onkaparinga River, then generally northerly and westerly along the low water mark on that side of the Onkaparinga River to the point of commencement, but excluding the Jubilee Park Reserve Adventure Playground (as defined in Port Noarlunga—Area 3).

8pm on each day to 6am on the following day until 6am on 31 March 2004.

The consumption and possession of liquor are prohibited.

Port Noarlunga—Area 3

(see Schedule 2: Port Noarlunga—Plan No 1, area 3)

Area

Period

Extent of prohibition

The area at Port Noarlunga as follows: that portion of the Jubilee Park Reserve (and adjacent land) defined in **Port Noarlunga**— **Area 2** that is enclosed within a picket fence and is known as the Jubilee Park Reserve Adventure Playground.

Continuous until 31 March 2004

The consumption and possession of liquor are prohibited.

(9) Schedule 1, item headed "**Woodcroft—Area 1**", column headed "*Extent of prohibition*"—delete "The consumption of liquor is prohibited" and substitute:


