### Part 1—Preliminary

#### 1—Short title

These regulations may be cited as the *Plumbers*, *Gas Fitters and Electricians (Fees) Variation Regulations* 2007.

#### 2—Commencement

These regulations will come into operation on 1 July 2007.

If the period between the grant of the licence and the next date for payment of a fee under section 11 of the Act is less than or more than 12 months, a pro rata adjustment is to be made to the amount of the additional fee by applying the proportion that the length of that period bears to 12 months.

3 Periodic fee for licence (section 11(2)(a) of the Act)—

(a)	for a natural person	\$268.00
(b)	for a body corporate	\$397.00

If the period between a date for payment of a fee under section 11 of the Act and the next date for payment of the fee under that section (as nominated by the Commissioner) is less than or more than 12 months, a pro rata adjustment is to be made to the amount of the fee by applying the proportion that the length of that period bears to 12 months.

4 Default penalty (section 11(3) of the Act) \$128.00

5 Application fee to vary or revoke a licence condition (section 7(2)(b) \$89.50 of the Act)

6 Application fee for registration (section 15(1)(b) of the Act) \$151.00

7 Registration fee—payable before the grant of registration under Part 3 \$187.00 of the Act

If the period between the grant of the registration and the next date for payment of a fee under section 18 of the Act is less than or more than 36 months, a pro rata adjustment is to be made to the amount of the additional fee by applying the proportion that the length of that period bears to 36 months.

8 Periodic fee for registration (section 18(2)(a) of the Act)

If the period between a date for payment of a fee under section 18 of the Act and the next date for payment of the fee under that section (as nominated by the Commissioner) is less than or more than 36 months, a pro rata adjustment is to be made to the amount of the fee by applying the proportion that the length of that period bears to

10 Application fee to vary or revoke a condition of registration (section 14(2)(b) of the Act) \$89.50

11 Fee for replacement of licence or certificate of registration \$20.00
