Part 1—Preliminary

1—Short title

These regulations may be cited as the *Private Parking Areas (Fees) Variation Regulations 2007*.

2—Commencement

These regulations will come into operation on 1 July 2007.

3—Variation provisions

In these regulations, a provision under a heading referring to the variation of specified regulations varies the regulations so specified.

4—Variation of regulation 5—Parking spaces

Regulation 5(1), expiation fee—delete the expiation fee

5—Variation of regulation 6—Protrusion over walkway or driveway

Regulation 6, expiation fee—delete the expiation fee

6—Variation of regulation 7—Obstructing access

Regulation 7, expiation fee—delete the expiation fee

7—Variation of regulation 8—Purpose other than parking

Regulation 8, expiation fee—delete "\$19" and substitute:

8—Variation of regulation 9—Damage to signs etc

Regulation 9, expiation fee—delete "\$49" and substitute:

\$51

9—Variation of regulation 11—Owner and driver guilty of offence

Regulation 11—after the penalty provision insert:

Expiation fee:

- (a) for a contravention of regulation 5(1)(a)—\$19;
- (b) for a contravention of regulation 5(1)(b)—\$29;
- (c) for a contravention of regulation 6—\$39;
- (d) for a contravention of regulation 7—\$39.

10—Variation of regulation 12—Further offence each hour

Regulation 12, expiation fee—delete "\$18" and substitute:
