### **Part 1—Preliminary**

#### **1—Short title**

These regulations may be cited as the *Road Traffic (Miscellaneous) (Fees) Variation Regulations 2007*.

#### **2—Commencement**

These regulations will come into operation on 1 July 2007.

#### **3—Variation provisions**

In these regulations, a provision under a heading referring to the variation of specified regulations varies the regulations so specified.

### **Part 2—Variation of *Road Traffic (Miscellaneous) Regulations 1999***

#### **4—Variation of regulation 43—Fees for inspections**

- (1) Regulation 43(1)—delete the definition of *one-off motor vehicle* and substitute:

*further inspection* means an inspection undertaken to determine if faults or defects identified by a previous inspection have been corrected;

*heavy vehicle* means a vehicle that has a GVM greater than 4.5 tonnes or, in the case of a trailer, that has a GTM greater than 4.5 tonnes;

*LPG* means liquefied petroleum gas;

- (2) Regulation 43(1)—after the definition of *Transport Department inspection* insert:  
*written-off vehicle* has the same meaning as in Part 4A of the *Motor Vehicles Regulations 1996*.

- (3) Regulation 43(2) and (2a)—delete subregulations (2) and (2a) and substitute:

- (2) The following fees are payable for a Transport Department inspection of a vehicle (other than a bus) for the purposes of an approval under section 161A of the Act or an exemption under section 163AA of the Act where the approval or exemption is in relation to the use of the vehicle—

- (a) as part of a road train or B-double; or  
 (b) as part of a combination that, including its load (if any), is over 19 metres long or has a total mass over 42.5 tonnes:

| First inspection of a motor vehicle                          | \$264      |
| First inspection of a trailer (other than a converter dolly) | \$132      |
| First inspection of a converter dolly                        | \$66       |
| Further inspection of a vehicle                              | \$66       |

- (2a) The following fees are payable for a Transport Department inspection or Central Inspection Authority inspection of a vehicle (or, where a particular inspection is specified, for a Transport Department inspection or Central Inspection Authority inspection of that kind), other than an inspection referred to in subregulation (2):

| <b>1. Heavy vehicles and buses</b>  |            |
| (1) First inspection of a motor vehicle (other than a bus)  | \$198      |
| (2) First inspection of a trailer   | \$132      |
| (3) First inspection of a bus   | \$198      |
| (4) Further inspection of a vehicle   | \$66       |
| <b>2. Vehicles other than heavy vehicles or buses</b>   |            |
| (1) First inspection of a vehicle for the purposes of an exemption under section 163AA of the Act or regulation 46                    | \$198      |
| (2) First inspection of a written-off vehicle for the purposes of section 139(1)(ab)(i) or (ii) of the <i>Motor Vehicles Act 1959</i> | \$198      |
| (3) First inspection of LPG-converted vehicle for the purposes of the <i>Dangerous Substances Act 1979</i>                            | \$198      |
| (4) Any other first inspection of a vehicle   | \$132      |
| (5) Further inspection of a vehicle   | \$66       |

- (4) Regulation 43(3)—delete "\$7.20" and substitute:

\$7.50

- (5) Regulation 43(4)—delete "\$22.75" and substitute:

\$23.70

### **5—Variation of regulation 43A—Fees for vehicle permits etc**

- (1) Regulation 43A(1)—delete the definition of *oversize or overmass vehicle exemption* and substitute:

*heavy vehicle* means a vehicle that has a GVM greater than 4.5 tonnes or, in the case of a trailer, that has a GTM greater than 4.5 tonnes;

*oversize or overmass vehicle exemption* means an exemption granted by the Minister by instrument in writing under section 163AA of the Act in respect of a heavy vehicle, from—

- (a) a dimension limit in the vehicle standards; or
- (b) a mass or dimension limit in the mass and loading requirements;
- (2) Regulation 43A(2)—delete subregulation (2) and substitute:
- (2) A fee of \$58.50 is payable to the Transport Department on application for the issue or renewal of a vehicle permit for a vehicle or combination.
- (3) Regulation 43A(3)—delete "\$38.00" and substitute:
- \$39.50

**Note—**

As required by section 10AA(2) of the *Subordinate Legislation Act 1978*, the Minister has certified that, in the Minister's opinion, it is necessary or appropriate that these regulations come into operation as set out in these regulations.
