## Part 1—Preliminary

### 1—Short title

These regulations may be cited as the Valuation of Land (Fees) Variation Regulations 2007.

### Schedule 2—Fees and allowances

#### 1—Fees

- (1) For a copy of the valuation roll (section 21 of Act)—per \$10 000 of 16.83 cents capital value of the land to which the roll relates
- (2) On an application for review of a valuation (section 25B of Act)-
  - of land used by the applicant solely as his or her principal \$79.00 place of residence

	• of any other land	\$195.00
(3)	For a certified copy of, or extract from, any entry in a valuation roll (section 32 of Act)	\$29.75
2—Allowances under section 25A(8) of Act		
(1)	For a review of a valuation of land used by the applicant solely as his or her principal place of residence	\$174.00
(2)	For a review of a valuation of any other land	\$213.00
