Health Care (HPC—Appointment of Members) Regulations 2008

1—Short title

These regulations may be cited as the *Health Care (HPC—Appointment of Members) Regulations 2008*.

2—Commencement

These regulations will come into operation on the day on which section 9 of the *Health Care Act 2008* comes into operation.

3—Interpretation

In these regulations—

Act means the *Health Care Act 2008*.

4—Establishment of Health Performance Council (HPC)

For the purposes of section 9(3) of the Act—

- (a) the following are prescribed bodies:
- (i) Aboriginal Health Council of South Australia Incorporated;
 - (ii) Australian Medical Association (South Australia) Incorporated;
 - (iii) Carers SA;
 - (iv) Consultative Council of Ex-Service Organisations (SA);
 - (v) Council on the Ageing (South Australia) Incorporated;
 - (vi) Health Consumers Alliance of South Australia Incorporated;
 - (vii) Multicultural Communities Council of South Australia Incorporated;
 - (viii) Regional Communities Consultative Council (SA);
 - (ix) Rural Doctors Association of South Australia Incorporated;
 - (x) S.A. Divisions of General Practice Incorporated;
 - (xi) The Flinders University of South Australia;

- (xii) The Returned & Services League of Australia (S.A. Branch) Incorporated;
 - (xiii) The South Australian Country Women's Association Incorporated;
 - (xiv) The University of Adelaide;
 - (xv) University of South Australia;
 - (xvi) Volunteering SA and NT Incorporated; and
- (b) the Minister is to consult with the prescribed bodies in relation to the selection of persons for appointment to HPC as follows:
- (i) when appointments are to be made to fill 2 or more vacancies, an invitation is to be extended to each prescribed body to recommend suitable candidates within a specified period;
 - (ii) the invitation is to specify the number of persons to be appointed and invite each body to recommend a specified number of suitable candidates consisting, as far as practicable, of equal numbers of men and women;
 - (iii) the invitation may specify areas of knowledge, expertise, experience, skills or qualifications listed in section 9(2) of the Act required of appointees and, if it does so, a recommendation of a candidate is to be accompanied by relevant information about the candidate's knowledge, expertise, experience, skills or qualifications.

Note—

As required by section 10AA(2) of the *Subordinate Legislation Act 1978*, the Minister has certified that, in the Minister's opinion, it is necessary or appropriate that these regulations come into operation as set out in these regulations.
