Part 1—Preliminary

1—Short title

These regulations may be cited as the *Harbors and Navigation (Fees) Variation Regulations 2009*.

2—Commencement

These regulations will come into operation on 1 July 2009.

3—Variation provisions

In these regulations, a provision under a heading referring to the variation of specified regulations varies the regulations so specified.

Part 2—Variation of *Harbors and Navigation Regulations 1994*

4—Substitution of Schedule 14

Schedule 14—delete the Schedule and substitute:

Schedule 14—Fees and levies

1—Waiver of fees and payment in instalments

- (1) The CEO may waive or reduce the fee payable by a person under these regulations if the CEO considers the circumstances of the particular case justify the waiver or reduction.
- (2) The CEO may allow a person to pay a fee in instalments.

2—Interpretation of table of fees

- (1) For the purposes of calculating a fee expressed as an amount per metre, part of a metre is to be regarded as a metre.
- (2) For the purposes of calculating a fee expressed as an amount per hour, part of an hour is to be regarded as an hour.
- (3) For the purposes of this Schedule, an observation vessel is to be regarded as a Class 3 vessel.
