### **Part 1—Preliminary**

#### **1—Short title**

These regulations may be cited as the *Mining (Fees) Variation Regulations 2009*.

#### **2—Commencement**

These regulations will come into operation on 1 July 2009.

### **Schedule 3—Annual rents**

1	Mining lease	\$156.00 or \$40.75 for each hectare or part of a hectare in the area of the lease, whichever is the greater
2	Retention lease	\$156.00 or \$20.60 for each hectare or part of a hectare in the area of the lease, whichever is the greater
3	Miscellaneous purposes licence	\$156.00 or \$40.75 for each hectare or part of a hectare in the area of the licence, whichever is the greater
