Part 1—Preliminary

1—Short title

These regulations may be cited as the Sewerage (Fees) Variation Regulations 2009.

2—Commencement

These regulations will come into operation on 1 July 2009.

4—Variation of regulation 36—Other charges

Regulation 36(1)—delete subregulation (1) and substitute:

 - (a) Standard capital contribution \$5 745.00
 (b) Installation of sewer connection (including sewer connection application fee)

(1)	Visit in relation to the non-payment of a charge or other amount to the land in relation to which the charge or amount is payable	\$28.50
