already paid in respect of

the action in the Magistrates Court

(2) Schedule 1, table—after item 5 insert:

5A On transferring a counterclaim or third party action commenced in the Magistrates Court to the Court

(a) in the case of a prescribed corporation \$1 708.00 less the fees

already paid in respect of

the action in the Magistrates Court

(b) in any other case \$1 212.00 less the fees

already paid in respect of

the action in the Magistrates Court

5B On filing a notice of appeal to the Court constituted of a Judge (other than a notice of appeal to the ADD)

(a) for a prescribed corporation \$1 708.00(b) for any other person \$1 212.00
