Part 1—Preliminary

1—Short title

These regulations may be cited as the *Registration of Deeds (Fees) Variation Regulations 2017*.

2—Commencement

These regulations will come into operation on 1 July 2017.

3—Variation provisions

In these regulations, a provision under a heading referring to the variation of specified regulations varies the regulations so specified.

4—Substitution of Schedule 1

Schedule 1—delete the Schedule and substitute:

Schedule 1—Fees

- 1 For registering—
 - (a) an instrument of conveyance, a legal or equitable mortgage or any other instrument
 - (b) an instrument of conveyance, mortgage or other instrument that No fee has been dated 30 years or more prior to production for registration

2	For depositing a deed, agreement, writing, assurance, map or plan	\$21.60
3	For enrolling an instrument	\$21.60
4	For a copy of an instrument that has been registered, deposited or enrolled	\$10.40
