#### **1—Short title**

These regulations may be cited as the *Bills of Sale (Fees) Regulations 1995*.

#### **4—Fees payable to the Registrar-General**

The fees set out in Schedule 1 are payable to the Registrar-General.

	(a) a Bill of Sale	\$58.50
	(b) the discharge, extension, transfer or renewal of a Bill of Sale	\$58.50
	(c) any other document	\$58.50
2	For withdrawing a Bill of Sale from registration or filing	\$48.00
