1—Short title

These regulations may be cited as the *Goods Securities Regulations 1999*.

4—Interpretation

In these regulations—

Act means the *Goods Securities Act 1986*.

5—Fees

The fees set out in the Schedule are prescribed for the purposes of the Act.
