### **LEGISLATIVE HISTORY**

**Citation**

1. These regulations may be cited as the *Youth Court (Fees) Regulations 1996*.

**Commencement**

2. These regulations will come into operation on 1 July 1996.

**Revocation**

3. The *Youth Court (Fees) Regulations 1995* (see *Gazette* 5 October 1995 p. 906) are revoked.

**Interpretation**

4. In these regulations, unless the contrary intention appears—

"**the Act**" means the *Youth Court Act 1993*.

**Fees**

5. (1) Pursuant to section 33 of the Act, the fees set out in the schedule are payable to the Court in relation to proceedings in the Court.

(2) The Court may require a non-refundable deposit as security for the payment of fees for the production of a transcript of the hearing of a case at the request of a party where the Court does not require the transcript.

6.	For computer disc containing record of court proceedings (including reasons for judgment)	The fee that would be payable under these regulations for a printed copy of the record of the proceedings plus \$55 for each day or part of a day on which the proceedings were recorded.
7.	For production of transcript at request of a party where the Court does not require the transcript	\$10 per page
