An Act to authorise the construction of a Well, Reservoir, and other Works for the purpose of affording a Supply of Water to the Corporation and Town of Gawler and lands adjacent, and for other purposes.

[Assented to, October 25th, 1880.]

TITHEREAS it is desirable to authorise the construction of a well, Preamble. reservoir, and other works for the purpose of affording a supply of water to the Corporation of the Town of Gawler and lands adjacent, hereinafter called the District of Gawler, according as the said district is defined in the Schedule hereto: And whereas plans and sections showing the source of supply, the said well, reservoir, and other works, and the direction of the main and branch pipes, and the streets and grounds through which they are to be laid, and also books of reference containing the names of the owners and occupiers, or reputed owners and occupiers (so far as known), of any private lands through which any of the said works will pass, have been deposited in the office of the Surveyor-General at Adelaide —Be it therefore Enacted by the Governor of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said province, in this present Parliament assembled, as follows:

1. The Commissioner of Waterworks may construct, out of any Commissioner of moneys which have been, or hereafter may be, voted by Parliament Commissioner of Waterworks may construct well, for such purpose, the well, reservoir, and other works in accordance reservoir, and other with the plans and sections deposited as aforesaid in the office of the Surveyor-General at Adelaide.

Errors and omissions in plans, &c., may be corrected by Justices, &c.

2. If any error, omission, misstatement, or wrong description shall have been made of any lands, or of the owners or occupiers or reputed owners or occupiers of any lands, delineated or shown on the said plans or sections or described in the books of reference deposited as aforesaid, the Commissioner of Waterworks, after giving ten days' notice to the owners or occupiers, or reputed owners or occupiers, of the lands affected or likely to be affected by the correction of such error, omission, misstatement, or wrong description, may apply to any two Justices to correct the same; and if it shall appear to such Justices that it is expedient and not unjust to correct such error, omission, misstatement, or wrong description, they shall give the said Commissioner a certificate in such form as they shall think proper, and shall in such certificate state the particulars of any such error, omission, misstatement, or wrong description, and such certificate with the documents to which it refers shall be deposited with the other documents to which they refer in the office of the Surveyor-General, and thereupon such plans, sections, or books of reference shall be deemed to be corrected according to such certificate, and the said Commissioner may make, complete, extend, and maintain the works hereby authorised in accordance with such certificate as if such error, omission, misstatement, or wrong description had not been made.

Surveyor-General to keep plans, &c. 3. The Surveyor-General shall keep the said plans and sections and books of reference and all other documents deposited with him for the purpose of this Act, and shall allow all persons interested to inspect any of the documents aforesaid, and to make copies of and from the same.

Incorporation.

4. Except so far as the same are inconsistent with or altered by this Act—"The Adelaide City, Port, and Suburban Waterworks Act," "The Lands Clauses Consolidation Act," and an Act No. 26 of 1855-6, intituled "An Act to Amend the Lands Clauses Consolidation Act," shall be incorporated herewith, and for the purposes of this Act the expression "the promoters of the undertaking" whenever used in "The Lands Clauses Consolidation Act" shall mean the Commissioner of Waterworks, and the words "special Act" shall mean this Act.

Interpretation.

5. In the construction of and for the purposes of this Act and "The Adelaide City, Port, and Suburban Waterworks Act," when not inconsistent with the context, the expression the "undertaking" shall, in addition to the meaning assigned thereto by the said, "The Adelaide City, Port, and Suburban Waterworks Act," mean and include the well, reservoir, and other works hereby authorised to be constructed; the expression "lands" shall, in addition to the meaning assigned thereto by the said Act, mean and include the lands hereby authorised to be taken or used for the purposes hereof, and the expression "water area" shall, in addition to the meaning assigned thereto by the said Act, mean and include the District of Gawler, according as the boundaries thereof are defined in the Schedule hereto.

6. This Act may for all purposes be cited as the "Gawler Short title. Waterworks Act, 1880."

SCHEDULE.

Gawler District Water Area.

Commencing at the north-west corner of section 1723, Hundred of Munno Para; thence easterly along its northern boundary to its intersection with the production south-westerly of the south-eastern side of Mount-terrace, Township of Gawler South; thence north-easterly across the road and along said side of Mount-terrace to the north-west corner of allotment 350; thence easterly and east-north-easterly along the northern boundaries of allotments 350, 347, 341, and 356, in said township, to the north-east corner of the latter; thence north-northwesterly along the eastern boundary of allotment 355, to the south side of the South Para River; thence north-easterly and south-easterly along said side of river to its intersection with the production south-south-easterly of the western boundary of section 3073, Hundred of Barossa; thence north-north-westerly by said production to the northern boundary of section 5, Hundred of Nuriootpa; thence east-southeasterly along said boundary for about 1,600 links; thence north-north-westerly by a straight line to the south-east corner of section 3500, Hundred of Barossa; thence north-north-westerly along the eastern boundary of said section and eastern boundaries of sections 6 and 7, Hundred of Nuriootpa, to the south-west corner of section 12; thence northerly along the western boundary of said section and its production to the north side of the North Para River; thence westerly along said side of river to its intersection with the north side of road on the south boundary of section 10; thence west-north-westerly along said side of road to the east side of road east of section 9, Hundred of Mudla Wirra; thence northerly along said side of road to its intersection with the production north-easterly of the south-western boundary of section 134; thence south-westerly across the road and along the southeastern boundary of said section to its south-east corner; thence west-north-westerly along its southern boundary to a point opposite the north-east corner of section 692; thence across the road to said corner, and south-westerly along the north-western side of road, forming part of the south-eastern boundary of said section, and through part of same to its south corner; thence across the road to the northeast corner of section 724, and south-south-westerly along its eastern boundary to its intersection with the south-western side of the Adelaide and Kapunda railway line; thence south-easterly along said side of railway to the western side of road through sections 2 and 8; thence southerly along said side of road and the eastern boundary of section 3221, Hundred of Munno Para, to a point opposite the south-west corner of allotment 8, Township of Evanston; thence easterly across the road and along the southern boundary of said allotment to the north-east corner of allotment 9; thence southerly along the eastern boundaries of said allotment to a point opposite the north-west corner of section 1723, Hundred of Munno Para; thence east-south-easterly across the road to the point of commencement.
