An Act to amend the Licensed Hawkers Acts, 1863
to 1912.

[Assented to, November 2nd, 1927.]

BE it Enacted by the Governor of the State of South Australia,
with the advice and consent of the Parliament thereof, as
follows :

1. (1) This Act may be cited as the "Licensed Hawkers Act Amendment Act, 1927". Short titles.

(2) The Licensed Hawkers Acts, 1863 to 1912, and this Act may be cited together as the "Licensed Hawkers Acts, 1863 to 1927".

2. This Act is incorporated with the other Acts mentioned in section 1 of this Act, and those Acts and this Act shall be read as one Act. Incorporation.

3. (1) The Commissioner of Police is hereby charged with the administration of the Licensed Hawkers Acts, 1863 to 1912. Administration by Commissioner of Police.

(2) After the passing of this Act all licences issued pursuant to the said Acts shall be issued by the Commissioner of Police in place of the Treasurer. Every licence shall be in the form fixed, from time to time, by the Commissioner of Police.

(3) The Commissioner of Police may refuse to issue a licence to any person who, in the opinion of the Commissioner of Police, is not a fit and proper person to whom a licence should be issued.

4. The Schedule to the Licensed Hawkers Act, 1863, is hereby repealed. Repeal of 3, 1863, The Schedule.

5. Section 4 of the Licensed Hawkers Amendment Act, 1898, is amended by striking out the words "and that he has resided in South Australia for at least two years" in the fourth and fifth lines thereof.

6. Sections 5 and 6 of the Licensed Hawkers Amendment Act, 1898, are hereby repealed.

7. The Schedule to the Licensed Hawkers Amendment Act, 1898, is further amended by inserting the following items before the last line thereof, namely:—

For a licence to hawk with one pack animal, per annum	1	0	0
For a licence to hawk with more than one pack animal, per annum, £1 for the first pack animal, plus 10s. for every additional pack animal, but so that the total fee shall not exceed	3	0	0
