**No. 34 of 1956.****An Act to amend the Police Pensions Act, 1954.**

[Assented to 15th November, 1956.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows :

1. (1) This Act may be cited as the "Police Pensions Act Amendment Act, 1956". Short titles.

(2) The Police Pensions Act, 1954, as amended by this Act, may be cited as the "Police Pensions Act, 1954-1956".

(3) The Police Pensions Act, 1954, is hereinafter referred to as "the principal Act".

2. This Act is incorporated with the principal Act and that Act and this Act shall be read as one Act. Incorporation.

3. This Act shall come into force on a day to be fixed by the Governor by proclamation. Commencement.

4. (1) Section 14 of the principal Act is amended by striking out subsection (2) thereof and inserting in lieu thereof the following subsection :— Amendment of s. 14 of principal Act— Amount of contribution.

(2) The annual contribution payable by a commissioned officer of the Force shall be the amount prescribed by subsection (1) of this section plus a proportion of that amount determined by the rank of the officer in accordance with following table :—

Inspector, third class . . . . .	one-fifth
Inspector, second class . . . . .	one-quarter
Inspector, first class . . . . .	one-third
Senior inspector . . . . .	two-fifths
Superintendent . . . . .	one-half
Deputy Commissioner . . . . .	one-half
Commissioner . . . . .	one-half

(2) Section 14 of the principal Act is further amended by striking out the words "fifty-four pounds" in the seventh line of subsection (3) and inserting in lieu thereof the words "sixty seven pounds ten shillings".

5. The following section is enacted and inserted in the principal Act after section 30 :—

Amended rates  
of pension and

officers.

30a. The amount of any cash payment (other than a refund of contributions or of twice the amount of contributions) and of any limit of a cash payment, and the amount of any pension payable pursuant to this Act, to a commissioned officer who retires from the Force after the day of the commencement of the Police Pensions Act Amendment Act, 1956, and the rate of pension and cash payment (if any) payable to the widow of a commissioned officer who on or after that day retires from the force or dies while still a member of the force shall be the amounts or rates fixed by the other provisions of this Act and, in addition, a proportion of such amounts or rates determined by the rank of the officer in accordance with the following table :—

Inspector, third class . . . . .	one-fifth
Inspector, second class . . . . .	one quarter
Inspector, first class . . . . .	one third
Senior inspector . . . . .	two-fifths
Superintendent . . . . .	one-half
Deputy Commissioner . . . . .	one-half
Commissioner . . . . .	one-half
