An Act to amend the Nurses Registration Act, 1920-1966.

[Assented to 25th August, 1966.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

- 1. (1) This Act may be cited as the "Nurses Registration Short titles. Act Amendment Act, 1966".
- (2) The Nurses Registration Act, 1920-1966, as amended by this Act, may be cited as the "Nurses Registration Act, 1920-1966".
- (3) The Nurses Registration Act, 1920-1966, is hereinafter referred to as "the principal Act".
- 2. This Act is incorporated with the principal Act and that Incorporation. Act and this Act shall be read as one Act.
- 3. Section 5 of the principal Act is amended by striking out Amendment of principal Act, e. paragraph—

Five shall be nominated by the Royal Australian Nursing of nurser board. Federation (S.A. Branch)—

(a) one of whom shall be a registered psychiatric nurse or registered mental deficiency nurse elected by members who are registered psychiatric nurses or registered mental deficiency nurses, as the case may require; and

(b) another of whom shall be a person enrolled as a mothercraft nurse, as a nurse aide or as a dental nurse..

in subsection (2) thereof and inserting in lieu thereof the following paragraphs:—

Four shall be nominated by the Royal Australian Nursing Federation (S.A. Branch) one of whom shall be a person enrolled as a mothercraft nurse, as a nurse aide or as a dental nurse:

One shall be a registered psychiatric nurse or registered mental deficiency nurse elected in accordance with regulations made under section 44 of this Act by persons who are registered psychiatric nurses or registered mental deficiency nurses, as the case may require.

- 4. Section 44 of the principal Act is amended—
 - (a) by inserting after the word "by" in paragraph II of subsection (1) thereof the passage "persons who are";
 - (b) by striking out the passage "who are members" in paragraph II of subsection (1) thereof;
 - (c) by striking out the word "of" occurring before the passage "the Royal Australian Nursing Federation (S.A. Branch)" in paragraph 11 of subsection (1) thereof and inserting in lieu thereof the word "by";

and

(d) by inserting after the passage "the Royal Australian Nursing Federation (S.A. Branch)" in paragraph II of subsection (1) thereof the passage "and advising the Minister when such elections are made".
