**An Act to amend the Enfield General Cemetery Act,
1944-1960.**

[Assented to 17th November, 1966.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows :—

Short titles.

1. (1) This Act may be cited as the "Enfield General Cemetery Act Amendment Act, 1966".

(2) The Enfield General Cemetery Act, 1944-1960, as amended by this Act, may be cited as the "Enfield General Cemetery Act, 1944-1966".

(3) The Enfield General Cemetery Act, 1944-1960, is hereinafter referred to as "the principal Act".

Incorporation.

2. This Act is incorporated with the principal Act and that Act and this Act shall be read as one Act.

Amendment of principal Act, s. 5—Membership of trust.

3. Section 5 of the principal Act is amended by striking out from paragraph (c) thereof the passage "Municipal Corporation of the Town of Enfield" and inserting in lieu thereof the passage "council of The Corporation of the City of Enfield".

Enactment of s. 6a of principal Act—

4. The following section is enacted and inserted in the principal Act after section 6 thereof :—

6a. (1) Where a member of the trust appointed pursuant to paragraph (c) of section 5 of this Act was, at the time of his appointment as such, a member of the council of The Corporation of the City of Enfield, he shall, notwithstanding any other provision of this Act, cease to be a member of the trust and vacate his office as such upon his ceasing to be a member of that council.

Member of trust who is also a member of the council of The Corporation of the City of Enfield to vacate office on ceasing to be member of that council.

(2) Subsection (1) of this section shall not apply to a person who immediately before the commencement of the Enfield General Cemetery Act Amendment Act, 1966, was a member of the trust and whose term of office had not expired at such commencement.

5. The following section is enacted and inserted in the principal Act after section 24 thereof:—

Enactment of s. 24a of principal Act—

24a. The trust may, with the consent of the Minister, borrow money for the purpose of erecting a crematorium or any building or of making improvements which the trust is authorized to erect or make under this Act and may, with like consent, mortgage or charge any portion of the land included in the cemetery which has not been developed prepared, set apart or used for burial purposes as security for the repayment of any money so borrowed together with interest thereon.

Trust may borrow money for erection of crematorium, etc.

6. Section 25 of the principal Act is amended by adding after paragraph III thereof the following paragraph:—

iv. In the repayment of moneys borrowed pursuant to section 24a of this Act and interest thereon and in the payment of expenses incidental thereto.

7. Subsection (2) of section 26 of the principal Act is amended—

Reserve fund.

(a) by inserting after the passage “securities of” therein the passage “or guaranteed by”; and

(b) by inserting after the word “Commonwealth” therein the passage “or in any securities guaranteed by or under the authority of any Act of the Parliament of the State or the Commonwealth or by the Treasurer of South Australia”.

8. Subsection (1) of section 31 of the principal Act is amended by striking out therefrom the passage “but not exceeding in

the case of the chairman fifty pounds a year or in the case of other members twenty-five pounds a year”.

9. Subsection (1) of section 33 of the principal Act is amended by striking out therefrom the word “shall” and inserting in lieu thereof the word “may”.
