An Act to amend the Waterworks Act, 1932-1975.

[Assented to 23rd March, 1978]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

1. (1) This Act may be cited as the "Waterworks Act Amendment Act, 1978". Short titles.
 - (2) The Waterworks Act, 1932-1975, is hereinafter referred to as "the principal Act".
 - (3) The principal Act, as amended by this Act, may be cited as the "Waterworks Act, 1932-1978".
2. Section 18 of the principal Act is amended by striking out the passage "five pounds", twice occurring, and inserting in lieu thereof, in each case, the passage "fifty dollars". Amendment of principal Act, s. 18—
Penalty for delay in reinstating streets.
 3. Section 38 of the principal Act is amended—
 - (a) by striking out the passage "five pounds" and inserting in lieu thereof the passage "fifty dollars";
 - and
 - (b) by striking out the passage "one pound" and inserting in lieu thereof the passage "ten dollars".Amendment of principal Act, s. 38—
Prohibition of laying gas pipes and tram rails in certain cases.
 4. Section 43 of the principal Act is amended by striking out the passage "twenty pounds" and inserting in lieu thereof the passage "two hundred dollars". Amendment of principal Act, s. 43—
Penalty for interfering with meter and power to recover cost of damage to fittings.
 5. Section 45 of the principal Act is amended by striking out from subsection (2) the passage "five pounds" and inserting in lieu thereof the passage "fifty dollars". Amendment of principal Act, s. 45—
Prohibition of alteration, etc., of pipes or fittings.

6. Section 46 of the principal Act is amended by striking out from subsection (2) the passage “five pounds” and inserting in lieu thereof the passage “fifty dollars”.
