An Act to amend the Workmen's Compensation (Special Provisions) Act, 1977-1978.

[Assented to 4 December 1980]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles.

1. (1) This Act may be cited as the "Workmen's Compensation (Special Provisions) Act Amendment Act, 1980".

(2) The Workmen's Compensation (Special Provisions) Act, 1977-1978, is in this Act referred to as "the principal Act".

Amendment of long title.

2. The long title to the principal Act is amended by striking out the passage "the definition of 'workman' in subsection (1) of section 8 of the Workmen's Compensation Act, 1971-1974" and substituting the passage "the definition of 'worker' in section 8 (1) of the Workers Compensation Act, 1971-1979".

Repeal of s. 1 and substitution of new section.

3. Section 1 of the principal Act is repealed and the following section is substituted:

Short title.

1. This Act may be cited as the "Workers Compensation (Special Provisions) Act, 1977-1980".

Amendment of s. 2—
Exclusion of certain persons from definition of "worker".

4. Section 2 of the principal Act is amended—

(a) by striking out from subsection (1) the passage "Workmen's Compensation Act, 1971-1974" and substituting the passage "Workers Compensation Act, 1971-1979";

and

(b) by striking out from subsection (1) the word "workman" and substituting the word "worker".

5. Section 3 of the principal Act is amended—

(a) by striking out from subsection (1) the passage "Workmen's Compensation Act, 1971-1974" wherever it occurs and substituting, in each case, the passage "Workers Compensation Act, 1971-1979";

(b) by striking out from subsection (1) the word "workman" and substituting the word "worker";

and

(c) by striking out from subsection (2) the passage "under the Workmen's Compensation Act, 1971-1974,".

6. Section 4 of the principal Act is amended by striking out the passage "Workmen's Compensation Act, 1971-1974" and substituting the passage "Workers Compensation Act, 1971-1979".

7. Section 5 of the principal Act is amended by striking out from subsection (2) the passage "thirty-first day of December, 1980" and substituting the passage "thirty-first day of December, 1982".

Amendment of
s. 5—
Expiry of Act.
