An Act to amend the Industrial Relations Advisory Council Act, 1983.

[Assented to 12 April 1990]

The Parliament of South Australia enacts as follows:

Short title

1. (1) This Act may be cited as the *Industrial Relations Advisory Council Act Amendment Act, 1990*.

(2) The *Industrial Relations Advisory Council Act, 1983*, is referred to in this Act as “the principal Act”.

Commencement

2. (1) Subject to subsection (2), this Act will come into operation on the day on which it is assented to by the Governor.

(2) Sections 3 and 4 will come into operation on 30 June, 1990.

Membership of the Council

3. Section 6 of the principal Act is amended—

(a) by striking out from subsection (1) “ten” and substituting “fourteen”;

(b) by striking out from paragraph (c) of subsection (1) “eight” and substituting “twelve”;

and

(c) by striking out from paragraph (c) of subsection (1) “four”, twice occurring, and substituting, in each case, “six”.

Proceedings of the Council

4. Section 9 of the principal Act is amended—

(a) by striking out from subsection (3) “Six” and substituting “Eight”;

and

(b) by striking out from subsection (3) “two”, twice occurring, and substituting, in each case, “three”.

Expiry of Act

5. Section 13 of the principal Act is amended by striking out “1990” and substituting “1993”.

Substitution of the schedule

6. The schedule to the principal Act is repealed and the following schedule is substituted:
