Emergency Management (Cross Border Travel—Associated Direction No 5) (COVID-19) Direction 2021

under section 25 of the *Emergency Management Act 2004*

Preamble

- 1 On 22 March 2020, I, Grantley Stevens, Commissioner of Police, being the State Co-ordinator for the State of South Australia pursuant to section 14 of the *Emergency Management Act 2004* (the *Act*), declared pursuant to section 23 of the Act that a Major Emergency is occurring in respect of the outbreak of the Human Disease named COVID-19 within South Australia.
 - 2 Now I, Grantley Stevens, Commissioner of Police and State Co-ordinator for the State of South Australia, being of the opinion that this is necessary to achieve the purposes of the Act, give the following directions pursuant to section 25 of the Act.
 - 3 This direction is to operate as an appendix to the *Emergency Management (Cross Border Travel—General) (COVID-19) Direction 2021*.

1—Citation

This direction may be cited as the *Emergency Management (Cross Border Travel—Associated Direction No 5) (COVID-19) Direction 2021*.

2—Revocation

The *Emergency Management (Cross Border Travel—Associated Direction No 4) (COVID-19) Direction 2021* is revoked.

3—Interpretation

In this direction—

Western Australia restricted zone means the restricted zone declared under clause 6;

Western Australia restricted arrival means a person arriving in South Australia who has, at any time during the period of 14 days before their arrival, been in the Western Australia restricted zone.

4—Application of cross border requirements—overseas arrivals

An arrival from a location specified in the first column of the table below who is of a class specified in the second column of the table is subject to requirements of the level specified in the third column of the table:

Location	Class of person	Level of requirements
Overseas	All overseas arrivals (other than New Zealand arrivals)	Level 5

5—Application of cross border requirements—Western Australia arrivals

An arrival from a location specified in the first column of the table below who is of a class specified in the second column of the table is subject to requirements of the level specified in the third column of the table:

Location	Class of person	Level of requirements
Western Australia restricted zone	Western Australia restricted arrivals arriving in South Australia on or after 17 April 2021 but before 12.01am on 24 April 2021	Level 3
Western Australia restricted zone	Western Australia restricted arrivals arriving in South Australia on or after 12.01am on 24 April 2021, who are— <ul style="list-style-type: none">• permitted arrivals; or• essential travellers.	Level 4
Western Australia restricted zone	Western Australia restricted arrivals arriving in South Australia on or after 12.01am on 24 April 2021	Level 6


6—Declaration of restricted zones

The area in the State of Western Australia comprised of the following regions under the *Planning and Development Act 2005* (WA) is declared to be a restricted zone:

- (a) Perth region;
- (b) Peel region.
