Emergency Management (Cross Border Travel— Associated Direction No 19) (COVID-19) Direction 2021

under section 25 of the *Emergency Management Act 2004*

Preamble

- 1 On 22 March 2020, I, Grantley Stevens, Commissioner of Police, being the State Co-ordinator for the State of South Australia pursuant to section 14 of the *Emergency Management Act 2004* (the *Act*), declared pursuant to section 23 of the Act that a Major Emergency is occurring in respect of the outbreak of the Human Disease named COVID-19 within South Australia.
 - 2 Now I, Grantley Stevens, Commissioner of Police and State Co-ordinator for the State of South Australia, being of the opinion that this is necessary to achieve the purposes of the Act, give the following directions pursuant to section 25 of the Act.
 - 3 This direction is to operate as an appendix to the *Emergency Management (Cross Border Travel—General) (COVID-19) Direction 2021*.

1—Citation

This direction may be cited as the *Emergency Management (Cross Border Travel—Associated Direction No 19) (COVID-19) Direction 2021*.

2—Revocation

The *Emergency Management (Cross Border Travel—Associated Direction No 18) (COVID-19) Direction 2021* is revoked.

3—Interpretation

In this direction—

designated exposure site means one of the sites in NSW restricted zone A listed from time to time as “COVID-19 case locations” on the following website maintained by the Government of New South Wales:

Greater Melbourne means the following local government areas in Victoria: Banyule, Hume, Moreland, Bayside, Kingston, Mornington Peninsula, Boroondara, Knox, Nillumbik, Brimbank, Manningham, Port Phillip, Cardinia, Maribyrnong, Stonnington, Casey, Maroondah, Whitehorse, Darebin, Melbourne, Frankston, Melton, Wyndham, Glen Eira, Monash, Yarra, Greater Dandenong, Moonee Valley, Yarra Ranges and Hobsons Bay, and the City of Whittlesea;

New South Wales restricted zones mean the restricted zones declared under clause 6(3), 6(4) and 6(5);

NSW restricted zone A arrival means a person arriving in South Australia who has been at a designated exposure site in New South Wales restricted zone A at a relevant time;

NSW restricted zone B arrival means a person arriving in South Australia who has been in New South Wales restricted zone B at any time in the 14 days prior to arrival (but not before 11 June 2021) and is not a NSW restricted zone A arrival;

NSW restricted zone C arrival means a person arriving in South Australia who has been in New South Wales restricted zone C at any time in the 14 days prior to arrival (but not before 11 June 2021) and is not a NSW restricted zone A or a NSW restricted zone B arrival.

New Zealand arrival—an overseas arrival is a New Zealand arrival if the only location outside of Australia that they have been in during the period of 14 days before their arrival in South Australia is New Zealand;

relevant time, in relation to NSW restricted zone A, means a time and date specified in relation to a corresponding exposure site within NSW restricted zone A;

Victorian restricted zone A arrival means a person arriving in South Australia who has been in Victorian restricted zone A at any time in the 14 days prior to arrival;

Victorian restricted zone B arrival means a person arriving in South Australia who has been in Victorian restricted zone B at any time in the 14 days prior to arrival and is not a Victorian restricted zone A arrival;

Victorian restricted zones mean the restricted zones declared under clauses 6(1) and 6(2).

4—Application of cross border requirements—overseas arrivals

An arrival from a location specified in the first column of the table below who is of a class specified in the second column of the table is subject to requirements of the level specified in the third column of the table:

Overseas	All overseas arrivals (other than New Zealand arrivals)	Level 5

5—Application of cross border requirements—New South Wales and Victorian arrivals

- (1) An arrival from a location specified in the first column of the table below who is of a class specified in the second column of the table is subject to requirements of the level specified in the third column of the table:

NSW restricted zone A	NSW restricted zone A arrivals arriving in South Australia after the commencement of this direction (including essential travellers and permitted arrivals other than domestic violence arrivals).	Level 6

NSW restricted zone B	NSW restricted zone B arrivals arriving in South Australia after the commencement of this direction (excluding essential travellers and permitted arrivals).	Level 6
NSW restricted zone B	NSW restricted zone B arrivals arriving in South Australia after the commencement of this direction and who are— <ul style="list-style-type: none"> • essential travellers; or • permitted arrivals. 	Level 4
NSW restricted zone C	NSW restricted zone C arrivals arriving in South Australia after the commencement of this direction.	Level 3
Victorian restricted zone A	Victorian restricted zone A arrivals arriving in South Australia after the commencement of this direction (excluding essential travellers and permitted arrivals).	Level 6

Victorian restricted zone A	Victorian restricted zone A arrivals arriving in South Australia after the commencement of this direction and who are— <ul style="list-style-type: none">• essential travellers; or• permitted arrivals.	Level 4
Victorian restricted zone B	Victorian restricted zone B arrivals arriving in South Australia after the commencement of this direction.	Level 3

- (2) Despite their classification as Level 3 arrivals, Victorian restricted zone B arrivals are not required to submit to COVID-19 testing on the 5th or 13th day after arrival.
- (3) Despite their classification as Level 3 arrivals, NSW restricted zone C arrivals must comply with the self-quarantining requirements until they undertake their first COVID-19 test after arrival, but do not have to quarantine while waiting to receive the results.

6—Declaration of restricted zones

- (1) Greater Melbourne is declared to be Victorian restricted zone A.
- (2) The State of Victoria other than Greater Melbourne is declared to be Victorian restricted zone B.
- (3) The area in the State of New South Wales comprised of the designated exposure sites is declared to be NSW restricted zone A;
- (4) The Waverley Council area is declared to be NSW restricted zone B; and
- (5) The Randwick City Council, Bayside Council, City of Canada Bay Council, Inner West Council, Council of the City of Sydney and Woollahra Municipal Council areas are declared to be NSW restricted zone C.

7—Prescribed roads

For the purposes of clause 16 of the *Emergency Management (Cross Border Travel—General) (COVID-19) Direction 2021*, the following roads are prescribed for any person entering South Australia from Victoria by road:

Sturt Highway, Yamba
Mallee Highway, Pinnaroo
Dukes Highway, Wolseley
Wimmera Highway, Laurie Park
Casterton Road, Penola
Glenelg Highway, Myora
Princes Highway, Glenburnie
Glenelg River Road, Donovans/Nelson

8—Modification of essential travellers—cross border community members

- (1) Despite this direction, a cross border community member who has not been within the State of Victoria outside of the cross border corridor in the 14 days prior to their arrival (except those who have been in the New South Wales restricted zones) is not subject to the level of requirements that apply to other essential travellers.
