Emergency Management (COVID-19) (Parafield Cluster Isolation No 3) Direction 2020

under section 25 of the *Emergency Management Act 2004*

Preamble

- 1 On 22 March 2020 I, Grantley Stevens, Commissioner of Police, being the State Co-ordinator for the State of South Australia pursuant to section 14 of the *Emergency Management Act 2004* (the *Act*), declared pursuant to section 23 of the Act that a Major Emergency is occurring in respect of the outbreak of the Human Disease named COVID-19 within South Australia.
 - 2 Now I, Grantley Stevens, being of the opinion that this is necessary to achieve the purposes of the Act, give the following directions pursuant to section 25 of the Act.

1—Short title

This direction may be cited as the *Emergency Management (COVID-19) (Parafield Cluster Isolation No 3) Direction 2020*.

1A—Revocation of previous directions

- (1) This direction replaces the *Emergency Management (COVID-19) (Parafield Cluster Isolation No 2) Direction 2020*.
- (2) The *Emergency Management (COVID-19) (Parafield Cluster Isolation No 2) Direction 2020* is revoked.

2—Application of direction

- (1) Except as provided in subclause (2), this direction applies to the following persons -
 - (a) a person who was physically present on the site of Roma Mitchell Secondary College (Briens Road, Gepps Cross SA 5094), on any 1 or more of the following days:
 - (i) 12 November 2020;
 - (ii) 13 November 2020; and
 - (b) a person who was physically present on the site of Thomas More College (23 Amsterdam Crescent, Salisbury Downs SA 5108), on any 1 or more of the following days:
 - (i) 12 November 2020;
 - (ii) 13 November 2020; and
 - (c) a person who was physically present on the site of Mawson Lakes Primary School (12-24 Garden Terrace, Mawson Lakes SA 5095), on the following day:
 - (i) 13 November 2020; and

- (d) a person who was physically present on the site of Elizabeth Aquadome (1 Crockerton Road, Elizabeth SA 5112) at any time during the following period:
 - (i) 11.00am – 1.30pm on 14 November 2020; and
 - (e) a person who was physically present on the site of Peppers Waymouth Hotel Adelaide (55 Waymouth Street, Adelaide SA 5000) at any time during the following period:
 - (i) 2 November until 15 November 2020 inclusive; and
 - (f) a person who was physically present on the site of, or who received a delivery from, the Woodville Pizza Bar (1/58 Woodville Road Woodville South SA 5011) at any time during the following period:
 - (i) 6 November until 16 November 2020 inclusive; and
 - (g) a person who was physically present on the site of SA Structural (40-54 Kaurua Avenue Edinburgh SA 5111) at any time during the following period:
 - (i) 7.30.am – 3.30pm on 12 November 2020; and
 - (h) a year 9 student of Woodville High School who was physically present on the site of the school (11 Actil Ave, St Clair SA 5011) on any 1 or more of the following days:
 - (i) 23 November, 2020;
 - (ii) 24 November, 2020; and
 - (i) any member of the household of a person identified in paragraphs (a), (b), (c), or (f), being a person regularly living in the household (or households if they live in more than one) of such a person.
- (2) Subclause (1)(e) does not apply to any person who was directed to enter the site of the Peppers Waymouth Hotel Adelaide as part of the COVID-19 outbreak response and was wearing full personal protective equipment.

3—Interpretation

- (1) In this direction, unless the contrary intention appears—
- day 1* means the day on which this direction comes into effect;
- day 12* means the day 11 days after day 1;
- relevant site* means a site listed in paragraphs (a) to (h) of clause 2.

4—Isolation requirement

A person to whom this direction applies—

- (a) must, unless paragraph (b) applies—
 - (i) travel by the most direct practical route and means to their residential premises, if not already at those premises; and
 - (ii) reside and remain at the premises, isolated and segregated from other persons:

- (A) in respect of persons identified in paragraphs (a) to (h) of clause 2(1), for the remainder of the 14-day period commencing on the last day on which the person was present at a relevant site; and
 - (B) in respect of a member of the household of a person identified in paragraphs (a), (b), (c) or (f) of clause 2(1), for the remainder of the 14-day period commencing on the last day on which the second-named person was present at a relevant site; and
- (iii) remain at those premises, except—
- (A) for the purposes of obtaining medical care or medical supplies; or
 - (B) in any other emergency situation; or
 - (C) for any reason approved in advance by the State Co-ordinator or his delegate or an authorised officer; or
 - (D) for the purpose of undergoing a COVID-19 test as specified in clause 5;
- during which times a mask must be worn whenever practicable and, in the case of a person leaving the premises to obtain a COVID-19 test, must travel directly to a testing site and inform the person performing the test of the reason for obtaining the test and the relevant site; and
- (iv) take reasonable steps to ensure that no other person enters the premises unless that other person—
- (A) usually lives at the premises; or
 - (B) is also complying with a direction to isolate; or
 - (C) is required to provide care and support to, or receive care and support from, the person to whom this direction applies at the place; or
 - (D) is required for medical or emergency purposes; and
- (v) follow all reasonable directions from a treating medical practitioner;
- (b) if advised by a medical practitioner of testing positive to COVID-19, must remain in a health or other facility in accordance with that advice, and must follow all reasonable directions from a treating medical practitioner, until a medical practitioner certifies that the person meets the criteria for discharge from a health or other facility.
- (c) must comply with subclause (a) irrespective of whether the person receives a ‘negative’ result on a COVID-19 test within the period that they are required to reside and remain at a premises, isolated and segregated from other persons.

5—Testing and symptoms of COVID-19

- (1) Subject to subclauses (2) and (3), a person to whom this direction applies must obtain a COVID-19 test on day 1 (or otherwise as soon as possible after that day) and on day 12 and otherwise when directed to do so by a person acting on behalf of SA Health or an authorised officer.

- (2) Subject to subclause (3), a person a person identified in paragraph (h) of clause 2(1) must obtain a COVID-19 test on day 1 (or otherwise as soon as possible after that day) and on 5 December 2020 and otherwise when directed to do so by a person acting on behalf of SA Health or an authorised officer.
- (3) A person to whom this direction applies who has obtained a COVID-19 test between the last day on which they attended a relevant site, being a date specified in subclause 2(1), and day 1 is not required to obtain a COVID-19 test on day 1.
- (4) A person required to submit to a COVID-19 test under this clause must not refuse or fail to comply with a reasonable requirement or direction of a person in relation to the conduct of the COVID-19 test.
- (5) If a person to whom this direction applies displays symptoms of COVID-19, the person must immediately notify SA Health of those symptoms.
- (6) In this section—

COVID-19 test means a Polymerase Chain Reaction test to diagnose COVID-19 of a kind determined by the Chief Public Health Officer (or delegate).


6—Powers of authorised officers

Nothing in this direction derogates from the powers of authorised officers to exercise powers pursuant to the Act.
