BY virtue of the powers conferred by the Administration of Acts Act, 1910, and the Manufacturing Industries Protection Act, 1937, I, the said Lieutenant-Governor, with the advice and

consent of the Executive Council, do hereby commit the administration of the Manufacturing Industries Protection Act, 1937, to the Minister of Industry and Employment.

HIS Excellency the Lieutenant-Governor directs it to be notified for general information that he has received a despatch from the Right Honourable the Secretary of State for Dominion Affairs, forwarding copy of Letters Patent passed under the Great Seal, dated the 10th January, 1938, further amending the Letters Patent of the 29th October, 1900, constituting the Office of Governor of the State of South Australia, as follows:—

SOUTH AUSTRALIA.

Letters Patent passed under the Great Seal of the Kealm, further amending Letters Patent of the 29th October, 1900, constituting the Office of Governor of the State of South Australia and its Dependencies, in the Commonwealth of Australia.

Dated 10th January, 1938.

GEORGE THE SIXTH, by the Grace of God, of Great Britain, Ireland and the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India; to all to whom these Presents shall come: Greeting!

Recites Letters Patent of 29th October, 1900.

Whereas by certain Letters Patent under the Great Seal, bearing date at Westminster the twenty-ninth day of October, 1900, Her Majesty Queen Victoria did constitute, order, and declare that there should be a Governor in and over Our State of South Australia and its Dependencies, in the Commonwealth of Australia (which said State and its Dependencies are therein and hereinafter called "the State":):

And whereas by the Eleventh Clause of the aforesaid Letters Patent Our said Governor was authorised and empowered to constitute and appoint a person to be his Deputy in the State during his temporary absence from the seat of Government or from the State:

And whereas We are minded to amend the aforesaid Eleventh Clause of the aforesaid Letters Patent:

Now know ye that We do hereby declare Our Will and Pleasure, and direct and ordain as follows:-

Substitutes fresh Clause for Eleventh Clause of Letters Patent of 29th October, 1900.

I. The aforesaid Eleventh Clause of the aforesaid Letters Patent of the twenty-ninth day of October, 1900, is hereby repealed and revoked, but without prejudice to anything lawfully done thereunder; and the aforesaid Letters Patent shall henceforth be construed and take effect as if, instead of the said Eleventh Clause, the following clause had been inserted therein:-

Governor may Appoint a Deputy during His Temporary Absence from the Seat of Government, or from the State, or in the Case of His Illness.

"XI. If the Governor shall have occasion to be temporarily absent for a short period from the seat of Government or from the State, or if by reason of any illness he considers it desirable so to do, he may in every such case, by an Instrument under the Public Seal of the State, constitute and appoint Our Lieutenant-Governor, or, if there be no such Officer, or if such Officer be absent or unable to act, then any other person, to be his Deputy during such temporary absence or illness, and in that capacity to exercise, perform, and execute for and on behalf of the Governor during such absence or illness, but no longer, all such powers and authorities vested in the Governor by these Our Letters Patent or otherwise as shall in and by such Instrument be specified and limited, but no others. Provided, nevertheless, that by the appointment of a Deputy as aforesaid, the power and authority of the Governor shall not be abridged, altered, or in any way affected, otherwise than We may at any time hereafter think proper to direct."

Power Reserved to His Majesty to Revoke, Alter, or Amend the Present Letters Patent.

II. And We do hereby reserve to Ourselves, Our heirs and successors, full power and authority from time to time to revoke, alter, or amend these Our Letters Patent as to Us or them shall seem meet.

Commencement of Operation-Publication.

III. And We do further direct and enjoin that these Our Letters Patent shall come into operation from the date hereof, and shall be read and proclaimed at such place or places within the State as the Governor shall think fit.

In witness whereof We have caused these Our Letters to be made Patent. Witness Ourself at Westminster, the tenth day of January, in the Second Year of Our Reign.
